ACTION ITEMS:

7. San Diego Country Estates request for a parking prohibition on San Vicente Road so that parking be prohibited on eastbound San Vicente Road (on the Southside) from 300 feet west of Country Villa Road to the east loop of the Green Haven Lane to enhance ability of motorists to merge on San Vicente

Presentation was made by Jerry Lyness and Lee Munsell of HOA Board of Directors of Villas II Condo Project as follows:

"Proposed and Recommended San Vicente Roadway Improvements -

In a sincere effort to improve San Vicente Road, which has caused traffic death and injuries in and about Villas II, being caused, in part, by sight line issues and parked vehicles on the roadway, we therefore offer the following recommendations.

Note: For purposes of identification, there are two traffic entrances into and out of Villas II from San Vicente Road and both connect to Green Haven Lane which serves exclusively the 110 Condo owners within the project. These two entrances are herein referred to as Green haven West and Green Haven East.

Recommendations: note all recommendations principally apply to the east bound traffic lane of San Vicente Road.

- A) On San Vicente Road, at the East entrance, extend the 'no parking' red painted curb, 115 LF west starting from the center line of the entrance
- B) On San Vicente Road, at the east entrance, within the roadway center median curb, construct a new traffic turning movement providing for west bound San Vicente vehicles to turn left into Green Haven Lane. Additionally, within the roadway center median, construct a new traffic turning movement providing for vehicles leaving Green haven Lane to turn left on the west bound lane of San Vicente.
- C) On San Vicente Road, at the west entrance, extend the 'no parking' red painted curd, 200 LF east starting from the center line of the entrance.
- D) On San Vicente Road, at the west entrance, extend the 'no parking' red painted curb, 200 LF east starting from the center line of the entrance.
- E) On San Vicente Road, at the west entrance, install new traffic warning flashing yellow caution lights.
- F) On San Vicente Road, between the west entrance and the east entrance, construct a new dedicated parking only lane, approximately 8 LF wide by approximately 325 LF."

The chairperson focused on each of these recommendations in order, allowing each to be fully explored and discussed with the presenting parties.... These results are as follow:

- A. Lynn thought it was a good idea. Ken asked about the line of sight, what HOA was asking and what was what County required. Dan stated that County would likely redline entire parking area because it is the easiest solution.
- B. Dawn asked for clarification on request to turn left from East entrance/exit. Jim asked about merge lanes on both entrances.
- C. Rick and Lynn agreed that County would likely redline whole area. Dan doesn't think recommendation is adequate. Dawn mentioned that she thinks this issues was discussed before and people needed parking.
- D. No notes
- E. Dawn didn't think it was necessary. Ken, Lynn and Dan thought yes.
- F. Rick was in favor, but not likely to happen. Dawn thought to red curb first, more line of sight and longer. Lynn, not going to happen. Ken thought maybe Condos can chip in. Dan asked if there were any other option? Jerry said no. Jim stated that Country Villa was more dangerous because of shrubs and parking.

During this discussion it was noted that the 110 condo's have about 167 total parking spaces for residence use.

At the conclusion of this thorough discussion, a Motion was made by Dawn Perfect that A,C and D be combined and approved with recommendation that County preserve some street parking while improving traffic safety and to also include a red painted curb west of Country Villa to the fire hydrant. Also, that there be a letter sent to County Estates HOA to trim shrubs to the right of Country Villa for improved line of sight. Seconded by Dan Scherer, Motion approved 5-1(Ken Brennecke)-0

A Motion was made by Ken to consider B,E, F as recommended. With no second, the motion failed.

A Motion was made by Lynn Hopewell to approve B as recommended but to also include construction of a new traffic acceleration lane for turning movement providing for vehicles leaving Green Haven Lane west to turn left on the west bound lane of San Vicente. Seconded by Dan Scherer, Motion Approved 5-1 (Dawn Perfect)
