C. Action Items:

**1. Action Item description: Tree Removal, 1324 Cornwall Street,** Presenter: Harris; Proponent: Sundahl. Request to remove Jacaranda tree. The tree is diseased and dying. The adjacent property owner is concerned about the tree falling. The property owner agrees to have it removed. The group reviewed the pictures provided by the county.

**2. Action Item description: Presentation Spring Valley Skate Park Committee,** Presenter: Christian M. Gregorio, Lezlie Hurtado and Felix Guerrero. These residents addressed the group to discuss the potential for a new skate park in Spring Valley. At one time there was a skate park in Spring Valley called "Skate Board Heaven" – 1977-79 (where the 125 freeway is now located). There are several locations that might be a good fit for a new park. One possible location is the current Caltrans lot along Sweetwater Rd. The speaker indicated that being able to skate at the old Spring Valley Skate park helped him stay out of trouble while he was growing up. There are grants available to help build a park. They would prefer a family-oriented park where family members, who

aren't skaters, could comfortably visit. There is interest in possibly including a BMX park adjacent to this park. Skate Boarding will be an Olympic Sport in the next Summer Olympics. Chris Pearson is willing to draft the letter of support.

The sub-committee members will be: Robles, Wilkinson, Harris, Custeau. Motion: Move that we form a sub-committee to look at M-54 properties and address potential changes to the signage portion of the Spring Valley Design Guidelines.
