- **C. PUBLIC COMMUNICATION** Opportunity for the public to speak to the Planning Group on any subject matter within our jurisdiction that is not on the posted agenda.
 - 1. Becky Rapp Came to the CPG to share updates related to marijuana issues impacting Spring Valley, the County and the State. Ms. Rapp highlighted the differences and similarities between regulated and unregulated dispensaries.
 - 2. Ryan Trabuco Represents Sup. Vargas' office. Provided brief updates on County Sign Initiatives and the Quarry Road Project
 - 3. Peggy Walker Came to share her opposition to commercial marijuana operations in the County because of the disparate economic impacts due to the nature of the business and the uneven distribution of tax revenue
 - 4. Lora Lowes Asked for Ryan Trabuco to clarify what County Sign Initiatives are underway.

D. Action Items:

- 1. Discuss and vote on suggested changes to our Community Design Guidelines, specifically for signage.
 - The Chairman opened the item by clarifying with CUSTEAU and LOWES that the purpose of the action item was to review the changes made to the Section E (Signage) of the Spring Valley Community Design Guidelines
 - LOWES asked that the group be very clear in the language specifying that the goal is to reduce and eliminate blight. LOWES also expressed a concern that by increasing sign size allowance, the community will see larger signs. LOWES also bought up the need to distinguish some of the language and expectations such as the difference between parapets, flat roof building, roof peaks and other architectural models.
 - HARRIS agrees the increase in sign sizes is merited, but suggested the group establish clear guidelines around brightness and illumination as well as hours of operation for those lights
 - ROBLES asked that the group use a central format for document sharing and editing, such as Google Docs because it allows everyone to provide input and track changes neatly.
 - EUGENIO recommended that the language in the guidelines that refers proponents to the Planning Group and that they work closely with the CPG, be moved to the front of the document to establish the importance
 - GIBBONS discussed the importance of a business' signage and explained how architects build sign space into buildings such as parapets, roof eyebrows. GIBBONS recommends the group leverage professional resources when trying to establish language because there are many different types of signs being used currently and not all are addressed in the current guidelines.
 - EBLE suggested the group increase the lettering sizes to 10 inches. Discussion led to not proceeding with that recommendation.

- 2. Discuss and vote on letter for St. George Street signage to restrict overnight parking.
 - SNYDER shared a letter with the CPG asking the County to review the parking situation in La Presa
 - Donna GORDON, a resident, expressed the challenges she is facing by having heavy commercial vehicles and RVs/Motorhomes park in front of her home. GORDON described human waste and needles as a common occurrence.
 - ROBLES added that the CPG had previously tried to address the parking issues in this neighborhood and that the
 CPG should request a more formal review of parking and traffic in this area. ROBLES reminded the group that
 there have been many accidents at the corner of St. George and Sweetwater, accidents at the ramp leading in to
 the shopping center and that things will only get worse as the shopping center grows. CUSTEAU offered several
 recommendations including red curbing. (See Letter)

- CUSTEAU also recommended the group forward these concerns to the specific agencies responsible to help expedite the process. SNYDER will forward the letter to Traffic Engineering and will follow up with other agencies to get coordination on the issue.
- PIERCE asked for the CPG to finalize the language before concluding the meeting.
