# 2. Informational Item, Spring Valley Trails and Calavo Park update from San Diego County Parks and Recreation.

Sean Hill, Region Manager for Parks and Recreation for the County of San Diego. Oversee operations and maintenance for parks in the greater Spring Valley area. Lizzy Bendrick, Trails Program Manager. Focus on regional trails. Brief overview of the CTMP, approved and adopted by the county board supervisors back in 2005 and it came from the public need to develop trails. While the CTMP was being developed, community groups including CPGs helped develop things like trail name, trail length. Future trails, ideally cover public land, semi public land and private land. Prioritize PTO funds through your CPG for trails. Damon Davis, PDS land use transportation specialist, During development, able to procure right of way or improvements for transportation. Received the grant for half \$1,000,000 from the state of California from Caltrans to work with SANDAG to develop a regional mitigation. The pathways and trails will be part of that strategy. Calavo Park was covered with the previous senior, so a new manager will be taking it through construction. Update on Calavo Park, Design Environmental is going to complete this fall which is now. So they are almost at the finish line and then expect to go out to bid in the winter. Hopefully January can start construction and expect that to be about a year. So they should have a new park here, winter 2024. Overview of Sweetwater Loop Trail on the reservoir, working on section 7, then 8, 9, and 10 in the planning stages. Construction in January and should be completed by summer. And then at that point we should be able to formally move in sections five through seven. The parks budget is going to have comprehensive update in 2028, we're looking at 7-8 years after that. Question came up about completion of access to Dictionary Hill Trails. Why haven't those things been worked on and

completed? Question on seeing another staging area at that end of the reservoir, little parking to reach the trails. Question on the need for a transition/animal access tunnel under Jamacha Blvd. They had not considered this and will look into. Question on Calavo Park. Now expected to start construction in January. Question on access to trail properties around the reservoir. Final question on Quarry Road Bridge, it would be nice to have a crosswalk for pedestrians to safely cross there.

**3. 8915 Troy St. APN, 503-292-0900 B waiver request for exemption from site plan permit processing.** Presenters or Shaffer and Snyder. The site designer, Chris, represented the property owner. The existing layout was compared to the new proposal. Demo the front bedroom of the house on the west edge of the property. Proposed landscaping was reviewed. Access the back of the property by a lane between the buildings and have the parking in the rear of the existing retail spaces. By doing this, they'll put some landscaping in front of the existing retail offices. A lot of businesses around the area park in front where sidewalks should be. So by adding some landscaping, they're hoping that that's going to be avoided. The actual parking space for the retail spaces will be in the rear. The previous elevations that they supplied to us a month or so ago, still stand as part of the improvement? Yes, if this is approved tonight, that would be part of the improvement. Whoever chooses to actually rent for retail, they're going to come back for the signage because there is a pretty bad sign and it's falling apart, so they know that it has to go.

Included tonight is improved fencing, making sure no parking out front, some landscaping, that's my opinion, not as significant as a site plan. You were originally submitted to the county and got them to submit the waiver request, correct? So this is actually the original plan. So that's what brought us here because the county did not want to take a pass on this. So based on the last thing that we had was kind of meet somewhere between a waiver and a site plan. SVCPG is always kind of stuck in the middle, but, at least, we gave him direction. So the past projects too is trying to get as close as they can to the Spring Valley Community Design Review guidelines and I feel like that's kind of what we've been working as a checklist. Question from resident live near the area. If you could fix the property, that would be nice. So we're kind of compromising here to get this site fixed. The designer expressed concern about the time and cost to improve any property in the area. He has not added a concrete sidewalk, but there is an asphalt one now.

Yes, existing signage will be removed and wrought iron fencing,, no barbed wire. Asked that they consider an attractive closure for the dumpsters, trash will be behind the retail buildings. There was a dumpster there before when the last owner was there. Motion that we approve this B waiver.
