**C. PUBLIC COMMUNICATION** – Opportunity for the public to speak to the Planning Group on any subject matter within our jurisdiction that is not on the posted agenda. A two (2) minute period shall be allotted to each person addressing the Group to facilitate business proceedings.

To keep the anonymity of the community the names of community members speaking will not be mentioned. Several members of the community came to the planning group asking for help with a property located at 1211 La Presa Ave. Concurring stories of multiple men on the sex offender registry are living on the same property. The Community was requesting that the planning group help them figure out a solution to this issue.

  - 2 Presentations were given on the project, one from Group Member ROBLES and one from a representative of the proponent.

Robles presented a power point relating to what a "B – Waiver request" is and how it affects the community and the planning group. Robles showed pictures of the property and made the group aware of some complaints against the property.

A representative from the proponent's property presented material similar to Member Robles. And addressed some of the complaints.

The group held a discussion about the project and concerns like parking, cleanliness, noise and the look of the business were brought up.

The community also discussed the property and brought up similar concerns.

**3. Standing Rules Updates:** Appoint a Subcommittee Chair, review proposed changes the subcommittee has made to date and provide suggestions/feedback. Vote on this item if necessary.

Discussion about the standing rules took place. Specifically, the group spoke about using Lakeside Community Planning Groups set of rules as more of a format and changing items in it to meet the needs of Spring Valley CPG. The groups spoke about changing "LCPG" to "SVCPG" and changing the title of the rules to being either Standing Rules or Rules of Order but not keeping the title as Standing Rules of Order. Member LAWSON was appointed as the Chair of the Ad Hoc Committee.
