- 2. Pledge of Allegiance.
- 3. Approval of February Minutes. Tony 1<sup>st</sup>, 2<sup>nd</sup> by Mark. All present members approved.
- 4. Public comment: S. Stonehouse expressed concern about previous interaction towards members regarding Quarry Rd votes. Pat Rourke requested info re: document "initiated by SCPG for proposed bike and walking paths along Proctor Valley Rd. and San Miguel Rd." Will submit copy of this found document and contact info for Rob DeBurn to this group. Judy suggested inviting County due to road hazards. Mark: add to future agenda. Susan H: "Residents don't want it." Penny suggested new seating arrangement for meetings.

- **5.** Order of agenda approval. See #8, 9 (cannot add these items at this time). 1<sup>st</sup> motion Mark, 2<sup>nd</sup> by Judy. Unanimous approval by present members.
- **6.** Phaylyn Keophakdy with Sprint Signs regarding Auto Zone signage: Motion by Mark and 2<sup>nd</sup> by Judy to approve nonilluminated channel letters for AutoZone at 24" height with downlighting did not pass. 7 ayes, 5 no (Lori, Harriet, Daniel, Judy, John). 2<sup>nd</sup> motion by same members for 18" nonilluminated letters with downlighting did pass with 11 ayes and 1 no (Harriet).
- 7. DPW Request List: Motion by Patty and 2<sup>nd</sup> by Mark to modify current project list (as per agenda items 7a thru 7f) by removing the following 2 items: (7c) Installation of crosswalk and warning lights where Dory Ln. meets Bonita Rd., and (7d) Construction of pathway alongside Frisbie St. This motion also included modification of (7f), removing "adding 3way stops at Jonel way and Bonita Meadows Ln.," as these have already been completed. Motion passed with 8 ayes, 2 no (Lori and Penni), 2 abstain (Tony and John).
