## **Regular Meeting Minutes**

- 1. Roll call by Secretary Lori Noe: All present except John Taylor and Harriet Taylor.
- 2. Pledge of Allegiance recited.
- 3. Approval of June 2025 Minutes: Motion to approve by Mark, 2<sup>nd</sup> by Liz: Michael Garrod abstained due to absence in June; all other members voted aye.
- 4. Public Comment: Update by Ernesto Castaneda, field representative for David Alvarez. Ernesto's focus is on a) transportation, b) military/veterans' affairs, and c) reconnecting communities, specifically those divided by freeways, such as with proposed "freeway lids." David Alvarez: Focus is on education policies, such as Chula Vista University Act, and also lack of sheriff presence in Bonita and unincorporated areas (meeting this Wednesday with sheriff's office), noise complaints from neighbors near rental properties used as venues, speeding. He has no jurisdiction over sheriff's department, but with CHP, yes. Announcement of Chicano Park concert events July 20 and Aug. 17. David Alvarez will be present for conversation. Flyers presented. Speaker Jim Groth has requested placement of "No Vending" signs on San Miguel Rd between Conduit and Bonita Rd. He stated that the Senator's office is looking at the Bill that allows vendors. Lori Noe reported roadside trash and overgrowth of weeds in sidewalks and along Briarwood Rd, as well as vehicles parked for long periods there. Encouraged by Judy to report on TellUsNow app. Felix Felix reported mail theft on the mesa. Uwe Werner reported that the stream on Proctor Valley Rd is being blocked and smelling like sewage, presumably due to actions by resident there. Judy stated that this was previously reported to Richard Whipple at the County, but she will readdress.
