## **Administrative Items**

Chair, Felix Felix called the meeting to order at 7:10.

Item #3: Opportunity for members of the public to speak to the Planning Group on any subject within Planning Group's purview but not on the agenda. ## **Action Items**

Item #4: Approval of order of the agenda - Liz made the motion, Uwe seconded. Passed with 12 voting Aye, no noes, two excused and one chair vacant.

Item#5: PLDO for Fiscal Year 2025-2026 presented by Chair. After much discussion, the PLDO list remains the same with added requests for benches every ¼ to ½ mile on our trails and Morrison Pond along with more trash cans and recycling receptacles. The other addition was to include converting the abandoned animal shelter into a Community Recreation Center with several programs for trail use, fitness and afterschool programs. Liz motioned to accept, Uwe seconded. Passed with 12 voting Aye, no noes, two excused and one chair vacant.

## **Non-Action Items**

Item #6: Presentation on Community Nuisance Noise, associated enforcement challenges and proposed solutions through stakeholder collaboration by Jesse Connor, Bonita-Sunnyside resident - Jesse started his presentation with whining noise and went on to give stats on what sleep deprivation can do, also discussing the sources of the noise, and the difficulty with Sheriff's resolve. suggestion, but the solution is to get new I.B. Lieutenant Chris Galve involved so he can provide resolve.
