1. COUNTY IMPLIMENTATION OF SB 743: Meeting to review and vote on comment letter to the County of San Diego regarding the County's response to Senate Bill 743 (SB 743). SB743 goes into effect July 1, 2020 and requires that transportation impacts under the California Environmental Quality Act (CEQA) be measures in Vehicle Miles Travel (VMT) and not Level of Service (LOS) (that looks at impacts from traffic congestion). The County has prepared a draft Transportation Study Guide that includes guidelines for determining significant transportation impacts under CEQA. How the County chooses to comply with SB 743 could have significant impact on the County and Twin Oaks community.
