Policy FP 2, Fire Code Compliance For Cellular Facilities: San Diego County Fire Authority (Authority) is asking for your review, feedback, and comments on to San Diego County Planning & Development Services Policy FP 2, Fire Code Compliance For Cellular Facilities. The purpose of revising this Policy is to provide more guidance to applicants regarding access, gates, walls, eaves, roofs, openings, fuel modification, standby power, signage and life safety equipment. The revisions also reflect the current Fire and Building Code references. All ten of the San Diego County Unincorporated Fire Districts have approved the revised Policy, so it will no longer be necessary to obtain PDS Form 399F (Fire Availability Form) from any of the districts. These revisions do not add any new steps to the current process of discretionary review for cellular facilities.
