2. Transportation Improvement Projects : The San Diego County Department of Public Works (DPW) requests your participation in identifying a prioritized list of transportation improvement projects on the county-maintained road network in your community.

Project types include the following:

1. *Road Reconstruction/Reconfiguration/New Roads:* Improvements include adding and/or modifying street lighting, lanes, turning lanes, roundabouts, or bike lanes to improve safety and/or increase roadway capacity.
2. *Bridges Repair/Reconstruction:* Improvements include adding and/or modifying street lighting, lanes, or bike lanes to improve safety and/or increase bridge capacity.
3. *Sidewalk/Pathways/Pedestrian Access Ramps:* Improvements include sidewalks, pathways, and ramps that promote safety and walking in the community.
4. *Drainage:* Improvements include corrections to storm drain problems on roadways or dip sections.
5. *Traffic Signals:* Installation of traffic signals to improve safety and traffic operation.

6. *Intersections*: Improvements could include new signals and turn lanes to improve safety and traffic operation.
