- 3. University of Saint Katherine Minor Use Permit: 2406 N Twin Oaks Valley Rd, San Marcos. The University of Saint Katherine is a non-profit, WSCUC-accredited institution of higher education that has been operating in San Marcos for approximately five years. They offer undergraduate and graduate degrees as well as professional certification preparation and our graduates have gone on to medical, dental, pharmacy, and law schools and graduate programs. They are requesting community feedback on their plan to construct student housing for 350 students at this site. The 17 acre site is currently operating as a church under a major use permit. - 4. PDS2021-AD-21-009 Administrative Permit, 2284 Sunshine Mountain Drive:

Permit for small Winery located at 2286 Sunshine Mountain Rd. Site is zoned A72/Semi Rural/SR10. Permit to construct and operate a small winery pursuant to Zoning Ordinance section 6910. The site currently contains an existing single family dwelling and boutique winery on 11.57 acres. The existing boutique winery will undergo an interior remodel to be converted to a small winery and proposes indoor and outdoor events with occupancy of 111-120 people with 49 parking spaces. There will be one event a month that will be held inside a tent to address noise issues and all events will finish by 10:30pm. The small winery will include a tasting room, bathrooms, a lab/break room, conference room/office, a receiving/storage area and wine production area. Access would be provided by a driveway connecting to Sunshine Mountain Drive, a private road. The project would be served by septic and imported water from the Vallecitos Water District.
