- PDS2022-MPA-22-009 Major Use Application, 3020 Lynn Lane:

Applicants for the Buena Vista Estate Event Venue, Heidi and Teresa Hanson, are proposing a 10,000 square foot event venue on property zoned RL-20/A-70 to be used for business meetings and private events. Property will also have a residence and ADU that is a separate project from this application. The event space will have stand-alone restrooms, structure to act as green room/storage area for clients, a small greenhouse for the purpose of photos and growing plants. Proposed office hours are Monday - Friday 9am-5pm, but event operation would take place Monday - Sunday from 10am to 10 pm, with an estimated 1-2 events per week at peak operation. Two permanent and three temporary staff is planned to be on site. Event capacity is 200 people per event with the major use being in the months of March through November. Shuttle bus will be used to pick and drop off visitors at a predetermined off-site location. 15 cars will be permitted on-site during the events. County is currently in scoping phase so this presentation by the applicant is for information only.

- 2. Repair of Culvert Headwalls at Lone Oak Road: This is a 69-inch culvert that conveys flows from Buena Creek under Lone Oak Road. The existing concrete headwalls that protect the culvert and roadway have been damaged and need to be replaced. The repairs are estimated to take 8 weeks with a target start date in the October/November 2022 timeframe.
