The project is a Tentative Parcel Map to subdivide a 16.92-acre parcel into one residential lot and one agricultural lot. The project site is located at 1977 Marilyn Lane in the Twin Oaks Valley Community Planning area, within unincorporated San Diego County. The site is subject to the General Plan Regional Category Semi-Rural, Land Use Designation Semi-Rural Residential 2 (SR-2). Zoning for the site is Limited Agriculture (A70). The site is developed with an existing single family dwelling that would be retained. The site also contains a barn and three greenhouses for an existing wholesale nursery that would be retained. The purpose of the Tentative Parcel Map is to divide the land into the residential use and the agricultural use. Access would be provided by driveways connecting to Marilyn Lane. The project would be served by on-site septic systems and imported water from the Vista Irrigation District. No grading is proposed.
