#### 2. Inclusionary Housing Ordinance Planning Commission Hearing

The County of San Diego's Planning Commission will be considering the following project and associated documents during the noted hearing date.

- Name: Inclusionary Housing Ordinance
- Date: April 19, 2024
- Project Description: Inclusionary housing is a tool used to help increase production of affordable housing by requiring that new developments provide affordable housing units as part of their project. Staff is requesting that the Planning Commission provide a recommendation to the Board of Supervisors on the proposed Ordinance and criteria options including which project types and locations the Ordinance would apply, the percentage of affordable units that should be provided, potential

alternative compliance options for when units cannot be provided on site, and incentives to help offset the cost of providing affordable housing units.

### 3. Update on Vehicle Miles Traveled Mitigation Program

This is to update you on the progress to implement the Board of Supervisors (Board) direction related to a Vehicle Miles Traveled (VMT) mitigation program.

On March 1, 2023, the Board received a report on VMT mitigation program options and provided direction to continue coordination with outside agencies and jurisdictions, to estimate costs to project applicants, to solicit stakeholder input, and to receive additional Board direction before the VMT mitigation program is fully developed.

A VMT mitigation program will play a role in determining where development efforts are focused in the unincorporated area, such as near jobs and transit to reduce travel and greenhouse gas emissions, consistent with the intent of Senate Bill (SB) 743, balanced with considerations regarding development feasibility.

On May 22, 2024, staff will provide an update to the Board on the development of the VMT mitigation program and options that staff are evaluating as part of the program. Discussion/Action item.

### CITIZENS NEEDED TO SERVE ON COMMUNITY ADVISORY BOARD

The Twin Oaks Valley Community Sponsor Group, a County appointed citizens advisory group that advises the County of San Diego on land use matters in the Twin Oaks Valley Planning Area is seeking applications for membership.

### What is the Twin Oaks Valley Community Sponsor Group?

This Group is one of 28 planning and sponsor groups in the unincorporated areas of San Diego County. Its purpose is to be an information link between the community and the County of San Diego on planning and land use matters in the local community. The group provides a public forum for the discussion of issues which are important to the community and all meetings are open to the public, held in a public place, and the agenda published according to Brown Act provisions.

Members are appointed by the Board of Supervisors and serve in an advisory capacity only to San Diego County Department of Planning and Development Services. Group members serve on a volunteer basis for a term of four years.

Members must be registered voters, and either be residents or own property in the Twin Oaks Valley Planning Area. Members to attend one evening meeting, held from 7-9pm, on the third Wednesday of each month. Members receive yearly training and take periodic online training as required for public officials.
