E. GROUP BUSINESS

- 1. Announcements and Correspondence:
 - Karve Ski Park, located within the Hidden Meadows Sponsor Group boundaries:
 - An application has been submitted to the County of San Diego for an outdoor, year-round synthetic snow sports complex and recreational park located JSO Deer Springs Road on the east side of the I15. The project includes artificial ski slopes, a magic carpet (standing ski lift), zip line, jump tower, village area amenities/services, an outdoor patio/pavilion, and restrooms. The village area amenities/services would include four buildings totaling 9,525 square feet (sf): a 2,000-sf box office and guest services, first aid, and management office; a 4,125-sf pavilion to include food and bar with seating indoor and outdoor with restrooms; 2,400 sf with equipment rental and event rooms; and 1,000 sf of maintenance and storage. The existing golf driving range use would be retained and operations would be limited to early morning hours when the ski park is not being operated. The project would include the installation of rooftop solar. The project is located at 26351 North Centre City Parkway within the Interstate 15 Design Review Corridor and the Hidden Meadows Community of the North County Metropolitan Subregional Plan Area. The Public comment period for this project ended October 6, 2025.
 - Mark Kieser from the County has sent his request for the 2025-2026 PLDO and recreational programming priority projects. Any new requests will need to be submitted prior to January 1, 2026.
 - Krystal from the City of San Marcos notified TOVCSG that we will not be able to use the Senior Center from January to April due to renovations. We will

- need to identify a new location to meet. Options that she offered at the same cost (\$50 per hour, 2 hour min) include: San Marcos Community Center (3 Civic Center Dr) Small Recreation Room, Dining Hall or the San Elijo Terrace Hall (1105 Elfin Forrest Road).
- Murali Pasumarthi of the Department of Public Works provided the 2025-2026
 County Road Resurfacing Plan as part of the 2017 commitment to county road
 resurfacing projects for Year 9 of the program. Within the Twin Oaks Valley
 Community, Mesa Rock Road has been flagged for resurfacing from Deer
 Springs Road to Windsong Lane, scheduled the Summer of 2026 through Fall

The Twin Oaks Valley Community Sponsor Group, a County appointed citizens advisory group that advises the County of San Diego on land use matters in the Twin Oaks Valley Planning Area is seeking applications for membership.

What is the Twin Oaks Valley Community Sponsor Group?

This Group is one of 28 planning and sponsor groups in the unincorporated areas of San Diego County. Its purpose is to be an information link between the community and the County of San Diego on planning and land use matters in the local community. The group provides a public forum for the discussion of issues which are important to the community and all meetings are open to the public, held in a public place, and the agenda published according to Brown Act provisions.

Members are appointed by the Board of Supervisors and serve in an advisory capacity only to San Diego County Department of Planning and Development Services. Group members serve on a volunteer basis for a term of four years.

Members must be registered voters, and either be residents or own property in the Twin Oaks Valley Planning Area. Members to attend one evening meeting, held from 7-9pm, on the second Wednesday of each month. Members receive yearly training and take periodic online training as required for public officials.
