B. Pledge of Allegiance: Meeting called to order at 6:30pm

C. Welcome & Introduction of Guests:

D. Approval of Minutes: No minutes to approve.

Public Comments:

Dr. Rattray addressed the concern of getting out of Valley Center, specifically in relation to the accident on the corner of Woods Valley Rd & Valley Center Rd.

E. Action Items:

- 1. Chair's Report: Community concern for the increase in migrant fires. There has been an influx of individuals trekking up the grade into Valley Center. VCCPG has received calls from the community with concerns about where these individuals are camping. Winds and dry weather do not make for a safe environment for campers. Chief Napier shared that a joint response from VCFPD & CAL Fire will assess the purpose of the fire. If fire is for warmth and cooking and is contained with clearance, then those individuals are allowed to continue. If there is not enough clearance, the fire is too large, or no real purpose i.e. bonfire; it is shut down. If wind is blowing, low humidity and the potential for fire spread is significant, it is shut down. Under very strict circumstance fires are allowed for cooking and warmth, however there must be adequate clearance, a contained fire area, ability to arrest sparks and prevent fire spread. Chief Reynolds added that arrests are made if fires are deliberately started or are illegal based on health & safety codes, investigators are brought in. If fires are started on private property and trespassing is involved, Sheriff is contacted.
- 2. VCFPD-Chief Napier: Zone Haven have been moving forward with County OES and CAL Fire. All public agencies are getting ready for training, probably starting in January. Grants are available for fire agencies in San Diego County to acquire Zone Haven maps that will replace the previous aged SDG&E maps. Training will start with new evacuation processes. This is a large partnership with former VC Evac members, Sgt. Mike Davis & Chief Rick Johnson leading this effort.

Conversations are continuing with Escondido re: the pass through from Mirar de Valle to Deer Springs. Apx. 1.25 miles needs improvement for this pass through. VCCPG can help by addressing issue with Escondido counterparts. Deer Springs will also benefit with an eastern exit should there be a westerly wind fire. And most importantly, no private property is affected.

Evacuation signs are not posted for the specific reason that fire conditions change quickly. Zone Haven will be immensely helpful when an evacuation is called for.

- 3. Deer Springs Fire Protection District-Chief Morrison: No Report.
- 4. **CAL Fire Update Station 71-Chief Reynolds:** Fully staffed with aircraft as well. This has been a relatively quiet year in California. Reynolds has been deployed to Maui for over a month. Stark comparison of resources between CA and HI. Our county and state is very fortunate.

Defensible space inspections are ongoing, roadside clearance and pretreatment on roads and surrounding areas. Truck trail maintenance will take place on Ridge Ranch.

Big push with Zone Haven, Reynolds has used it with instant management teams and considers it a great tool. San Diego County is the pioneer for evacuations using map grid system. Now Zone Haven will bring us even better evacuation management.

5. **Rincon Fire-Chief Duncan:** Small fire on reservation bordering SRA land. Addressing sirens, not the best methods to notify the public. WEA (wireless emergency alerts are far superior.

- 6. San Diego County Sheriff-Sgt. Tyler Skeels: No report.
- 7. LAFCO Update-James Gordon: Quarterly meeting produced agricultural trends report. Addressed policies to help farmers increase ag opportunities. VC area is very much an ag community and might be interesting to the community.

G. New Business:

Lisa Adams: Opposed to purchase of Butterfield Trails Park. County spending money on purchasing park lands is not best use of money. They should be using this money for Valley Center fire stations and VCFPD wages for firefighters. Harmes shared county has money to do both. One does not need to affect the other.
