## 1. Update on Oliver Smith, past Chair [APPENDIX]

• Mr. Hutchison shared that Oliver Smith passed away last week. He was the Chair of the VCCPG and was very involved in the community of Valley Center. He was an engineer and was engaged with a number of local governing boards. Mr. Hutchison will share with Mr. Garritson the tribute he delivered about Oiver Smith.

# 2. An overview of the Citrus Quarantine in Valley Center, Garrett Cooper & Jasmine Lopez, Dept. of Agriculture, Weights & Measures, County of San Diego

- Garrett Cooper and Jasmine Lopez introduced themselves and gave a presentation about the agricultural quarantines in the County.
- Jasmine Lopez is the Dept. of Agriculture for the County and provided information about the Asian Citrus Psylid. Huanglongbing (HLB) is a bacterial disease of citrus and citrus relatives. It is caused by the bacteria Candidatus Liberibacter asiaticus. There is no known cure for HLB. Once infected, a citrus tree will die.
- CDFA surveyors will collect leaf samples and any ACP life stages from all host plants.
- The insect was first discovered in California in 2008. LA County has 2,003 HLD detections; Orange County has 6,750 detections. Riverside County has 590 infected trees. San Bernardino has 660 infected trees. San Diego County has detected 109 infected trees. Ventura County has found 124 infected trees.
- CDFA shared a map of the areas that are in the HLB Quarantine. CDFA will not treat with chemicals if bees are present.

# 3. An update from the Office of Jim Desmond, Board of Supervisor, Adrienne Cisneros-Selekman, Community Liaison

- Adrienne thanked community members who showed up to the Butterfield Trails Ranch event. Supervisor Desmond and the community had a great time planting trees.

# Michael Kenney, Department of Public Works

- Michael provided an update on the Dark Skies ordinances and lighting standards. Michael shared that the Dark Skies Ordinance does not apply to the community of Valley Center. It does apply to the communities of Pauma Valley and Julian. Michael will try to replace lightbulbs that burn out with lighting that is more compliant with the Dark Sky Ordinances.
- Eddie Lain (community) shared details about some lights in Valley Center that he would like to dim or change the color luminosity. CEQA standards do not apply to traffic signals.

# 1. A recap and timeline update on the Cole Grade expansion and SDG&E undergrounding, Bob Littlejohn, Energy Subcommittee Chair (INFORMATIONAL)

Mr. Littlejohn presented slides about the Cole Grade Road widening project. It will precede
utility undergrounding at the Keys Creek location.

- Dewatering will not be needed for utility undergrounding; limited dewatering is needed for new bridge construction.
- Two lanes will remain open during construction most of the time. All powerlines will be undergrounded once this project is completed.

# 2. A community call to action regarding the Social Equitable Cannabis Program - Information Call on Friday, October 17, 2025, at 9:00 a.m. Matthews/Rattray

- Dr. Matthews and Chair Rattray shared that it is important for a number of people to attend the Social Equitable Cannabis Program Informational meeting this Friday. # **Oliver Smith Tribute by Steve Hutchison**

As you may have heard, Oliver Smith, a former member of the VCCPG and its past chair, died last week on October 7 after a battle with cancer.

For those of you who didn't know Oliver, he was a man dedicated to this community and its wellbeing. Besides serving for years on the planning group, he also served as secretary of the board of the Valley Center Fire Protection District, and as a board member of the Valley Center Municipal Water District. Some of you may know of him through his wife, Janice, who along with their daughter runs Inspirations Quilt Shop here in ValleyCenter.

My first acquaintance with Oliver was in 2009 when I started attending VCCPG meetings regularly. I had applied unsuccessfully to fill a vacancy in the group and Oliver suggested that I instead take a position as a community member on the Mobility Subcommittee, which I did. During his tenure on the VCCPG, Oliver was confronted with overseeing several major projects. One in particular was the revision of the County's General Plan, and especially those parts that affected Valley Center, which culminated in 2011 with adoption by the Board of Supervisors. Sadly, it did not include an updated community plan, but Oliver continued to pursue that goal for the rest of his tenure.

While Oliver and I agreed on many issues brought to the VCCPG, when we did disagree, Oliver generously didn't allow such disagreements to stand in the way of friendship. He strove for cooperation and equanimity as much as possible. Oliver was professionally an engineer, and he routinely considered all the evidence available before making a determination. It was that engineering ethic that guided him through the various land use issues presented to the VCCPG. But, when he was wrong or misinformed, he admitted it and moved forward.

As a member of the fire protection district board, Oliver was active in making the transition from dependence on CALFIRE personnel to our own independent local agency. While he was on the board, the district hired our first independent fire chief, and began the long effort to raise the status and pay of our firefighters and improve the infrastructure that supports them so the community would have lower insurance rates and quicker and more effective emergency responses.

I think Oliver's interest in water as a commodity actually began with a program offered by the water district that introduced him to the extensive infrastructure responsible for collecting, treating and distributing our water. As an engineer, it's not hard to understand his attraction to that system. He continued to serve on that board until this year.

Oliver Smith demonstrated through his engagement in local governing boards the impact a single citizen can have to shape the contours of the community. His willingness to devote his time and energy to wrestle with the decisions put before the community is his legacy, and one we can all appreciate and aspire to emulate.
