Special Presentation

Discussion on Creating a County/Community Park in Warner Springs

Mark Kieser, Senior Park Project Manager, presented the process for establishing a county/community park. Key points included:

- Funding a major issue. PLDO funds (only approximately \$67,000 currently available) come from building permits and can be used to pay for trails, parking, playground equipment, etc.
- Steps for property acquisition (willing seller letter), Board of Supervisors approval, community involvement, and park design.

- Considerations for a hybrid community and county-managed park model were discussed.

Action Items

1. Recommendation to Seat Todd Hipper as a New Member

Discussion was held regarding Todd Hipper's application to fill one of the open positions on the CSG. Because Mr. Hipper was unable to attend due to a prior commitment, the motion was tabled.

- 7. Socially Equitable Cannabis Other CSGs looking at this issue as well.
