Mark – Parks dept. essentially given no new funding for next 1-2 years. A development such as the WSRR with 51+ proposed housing units will require park land set aside.

Bob moves to establish an ad hoc subcommittee composed of less than a quorum of the board members, for the temporary purpose of exploring opportunities for a community park in Warner Springs, including identifying potential locations, assessing community needs, and researching available funding sources. The subcommittee is advisory only, has no decision-making authority, and will report its findings and recommendations to the full sponsor group on a monthly basis. Kathryn appoints Bob to chair the subcommittee with Nina and Michael members. Nina seconds the motion, all vote in favor.
