#### A. EXECUTIVE SUMMARY

#### 1. Introduction

The purpose of this staff report is to provide the Planning Commission with the information necessary to consider an appeal of the Determination of Public Convenience or Necessity Determination (Determination) made by the Director of Planning & Development Services (PDS) on November 15, 2019.

On August 22, 2019, a Rite-Aid store and pharmacy located in the Valley Center Community Plan area submitted a request for a Type 21 Alcoholic Beverage Control (ABC) license to allow the sale of beer, wine, and spirits for off-site consumption.

To obtain a Type 21 ABC license, prior to submittal to the County, the applicant submits an application to the State ABC Department. During processing, if the State determines that the censustract in which the proposed license is located has an over-concentration of either existing ABC licenses or reported crime, the State requests that the local governing agency follow Business and Professions Code (BPC) Section 23958.4 (Attachment I) to make a Determination for the proposed license. The local governing agency does not grant a requested ABC license, but makes a Determination, or recommendation, that the State ABC Department must act on.

County of San Diego Board of Supervisors Policy I-121 (Attachment H) details the processing of proposed ABC license projects in the unincorporated County, and provides three criteria that must be satisfied in order for the County to determine that public convenience or necessity will be served

by the ABC license. PDS, the Sheriff's Department, and Health and Human Services Agency all coordinate on the review. PDS makes findings related to the impact on crime in the neighborhood, compatibility with community character, and any building or health code violations existing on the site, taking into consideration the Sheriff's Department's recommendations and input from Health and Human Services. If PDS determines that public convenience or necessity will be served by the issuance of a requested ABC license, it transmits the Determination to the State ABC Department who will then grant the requested license and may impose the Sheriff's Department's recommended conditions on the license.

The Planning Commission is asked to consider the appeal of the Director's Determination made by the Valley Center Community Planning Group on December 9, 2019.

This report describes the following: ABC license proposal, analysis and discussion, community planning group input, and the PDS recommendation.

#### 2. Requested Actions

Staff recommends that the Planning Commission take the following action:

Deny the Valley Center CPG appeal and uphold the Director's Determination of Public Convenience or Necessity for the proposed Type 21 ABC license (Attachment C).

#### B. DEVELOPMENT PROPOSAL

#### 1. Project Description




Figure 1: Vicinity Map

The applicant requests a Type 21 Alcoholic Beverage Control (ABC) license to allow the sale of beer, wine, and spirits for off-site consumption for the Rite-Aid store and pharmacy located at 28535 Cole Grade Road in the Valley Center Community Plan area within the unincorporated County (Figure 1). The Rite-Aid store Site Plan was approved by the Director of PDS in 2018 and was subsequently appealed to the Planning Commission by the Valley Center Community Planning Group (CPG). The Valley Center CPG appeal was denied by the Planning Commission on August 3, 2018 by a vote of 6-0-1 (ayes, noes, absent). The store, which opened on January 23, 2020, is located on 1.16 acres and contains approximately 11,872 square feet (SF) of retail space with associated parking, landscaping, and a drive-through pharmacy.




Figure 2: Census Tracts




Figure 3: Census Tracts

The property is within census-tract 191.06 which encompasses approximately 30 square miles (Figures 2 & 3). The State ABC Department uses census-tracts, a geographic region defined for taking a census, and population data to determine how many ABC licenses can be granted in a census-tract, before becoming over-concentrated with ABC licenses. One license for off-site sales is considered for each group of 1,614 persons. Based on population, census-tract 191.06 is allowed five off-sale ABC licenses before being considered by the State to be over-concentrated. At the time of the Rite-Aid ABC license submittal, the census-tract had five existing licenses: four Type 20 licenses (sale of beer and wine for off-site consumption) and one Type 21 license (sale of beer, wine and spirits for off-site consumption).

The process for obtaining an ABC license begins with the State ABC Department. If the State determines that a determination is required, the applicant is instructed to obtain this Determination from the County. Upon submittal to PDS, staff reviews the request under the guidelines in Board

Policy I-121, to determine if findings related to impacts on crime in the area, compatibility with community character, and the existence of building or health code violations on the property can be made.

#### 2. Subject Property and Surrounding Land Uses




Figure 4: Surrounding Land Uses

Rite-Aid is bound by Cole Grade Road to the west and Valley Center Road to the north. Land uses surrounding the site are primarily commercial shopping centers and light industrial uses, with one single family home identified directly north of the project site (Figure 4). Other uses include a church, parks, and office space, including the Valley Center Municipal Water District offices, located approximately 0.2 mile east of Rite-Aid. A daycare center is located approximately 250 feet east of the Rite-Aid store, buffered by a concrete masonry wall and landscaping.

A convenience store with an existing Type 21 ABC license is located northwest of the project site, which falls within census tract 191.03 as seen in Figure 2. The existing five ABC licenses within census tract 191.06 include four Type 20 licenses and one Type 21 license. The Type 20 licenses are located at a gas station approximately 340 feet away, a 7 Eleven store approximately 4.8 miles away, a general store approximately 2.5 miles away, and a market approximately 5.4 miles away. The Type 21 license is located at a grocery store approximately 1.5 miles away from the Rite-Aid store.

The General Plan Regional Category for the site is Village, and the General Plan Land Use Designation is General Commercial. Zoning for the site is General Commercial (C36), which is intended for a wide variety of Civic and Commercial use types, including food and beverage retail sales.

Please refer to Attachment A – Planning Documentation, for maps of surrounding land uses and zoning designations.

#### C. ANALYSIS AND DISCUSSION

#### **Key Requirements for Requested Actions**

Does the Determination for the proposed Type 21 ABC license meet the following criteria from Board Policy I-121:

- a. Will not negatively influence the rate of criminal activity in the neighborhood.
- b. Is compatible with neighborhood character and would be of benefit to the neighborhood.
- c. The establishment has no Building Code or Health Code violations, and that the use is permitted by the applicable use regulations of the County Zoning Ordinance.

The project has been reviewed for conformance with Board Policy I-121; no other ordinances or guidelines are relevant for this project type. Concerns from neighbors were raised relating to compatibility with neighborhood character as discussed in the following sections.

#### 1. Factors for Public Convenience or Necessity Determination

In accordance with Board Policy I-121, findings must be made for the Determination of any proposed ABC license. Below is a discussion of each of the three criteria and staff's analysis.

#### Influence on Rate of Criminal Behavior

The Sheriff's Department determines that approval or conditional approval of the proposed ABC license sought by the retail outlet will not negatively influence the rate of criminal activity in the neighborhood. The Sheriff considers the following factors: (1) loitering and vandalism; (2) public drinking and drunkenness; (3) illegal drug use and sales; and (4) theft and violent behavior.

<u>Analysis:</u> The Sheriff's Department provided a letter stating that when properly conditioned by the State ABC, there is no reason to believe that the issuance of the proposed license will have a negative influence on crime related to loitering and vandalism, public drinking and drunkenness, illegal drug use and sales, and theft and violent behavior in the area pursuant to Board Policy I-121.

To make this determination, service calls made to the Sheriff's Department within a quarter-mile radius of the store were analyzed. The data showed that from January 1, 2017 to January 18, 2019, there were 323 total calls made for service: 26 were for incidents where persons were under the influence of drugs or alcohol, 14 were for petty theft or violent behavior, and two were for loitering and vandalism. This number of service calls is below average for a rural area, and the Sheriff does not anticipate the proposed license to have a negative influence on crime if approved, with the inclusion of conditions related to the hours of alcohol sales and the sizes of containers for certain types of spirits. Specifically, they request that no 'airline container' sized bottles (i.e. 50mL or less) are available for sale. Ultimately, the State ABC Department makes a determination on the inclusion of recommended conditions as part of the Type 21 ABC license.

#### b. Compatibility with Neighborhood Character and Neighborhood Benefit

The County determines whether the proposed ABC license is compatible with neighborhood character and if it would be of benefit to the neighborhood. Factors that are considered by the Director of Planning & Development Services include: (1) proximity and number of other outlets selling alcohol; (2) proximity of the retail outlet to schools, playgrounds, parks and other facilities serving young people; (3) proximity of the retail outlet to residential neighborhoods; and (4) whether the retail outlet provides a wide range of desirable goods and services, or a unique type of goods and services to the community.

<u>Analysis:</u> PDS reviewed the ABC license application for neighborhood compatibility and determined that the ABC license would be compatible with neighborhood character based on the following:

Proximity and Number of Other Outlets Selling Alcohol: In census tract 191.06, which is approximately 30 square miles, there are four existing retail outlets with a Type 20 ABC license, and one with a Type 21 ABC license. Four of the five existing licenses in the census tract are more than 1.5 miles away from the Rite-Aid store. The fifth license is approximately 340 feet away, located in a gas station northwest of the Rite-Aid store. Another retail establishment within 1,000 feet of the Rite-Aid store has a Type 21 license but lies within census tract 191.03. PDS determined that this is not an excessive number of outlets selling alcohol. Members of the public, including the Valley Center Community Planning Group (CPG), expressed concern with the overconcentration of ABC licenses in the area. On October 14, 2019, the CPG voted to recommend approval of a Type 20 ABC license, which would allow Rite-Aid to sell beer and wine only.




Figure 5: Existing schools and youth facilities within ½ mile of project site

Proximity to Schools, Playgrounds, and Other Facilities Serving Young People: State ABC guidelines may deny ABC licenses for establishments that are within 600 feet of a K-12 school. PDS analyzed a 1,000-foot radius around the Rite-Aid store; this distance was chosen as the maximum distance which could reasonably be impacted by the sale of alcohol since Board Policy I-121 does not specify any minimum distance an establishment must be from a school, playground, or youth facility. There are no schools or playgrounds within 1,000 feet of the Rite-Aid store. The nearest park is Cole Grade Park baseball diamond, approximately 700 feet away, and the store is located approximately 1,700 feet from the Valley Center Elementary School. The Valley Center Community Church is located to the west approximately 850 feet. A daycare, High Sierra Academy, is directly east of the store, though it is buffered by a concrete masonry wall and landscaping. There are no other schools, playgrounds, or facilities serving youth within a one-half mile radius of the project site (Figure 5). To aid in prevention of underage alcohol sales

and theft, Rite-Aid requires employees to pass annual training on alcohol sales. Additionally, their corporate store policy requires all bottles of liquor are behind the sales counter or have safety locks, requiring a key to unlock at time of purchase.

**Proximity to Residential Neighborhoods**: The Rite-Aid store is located in a General Commercial (C36) zone. The store is directly south across Valley Center Road from the nearest residentially zoned property with one existing single-family home, while the nearest neighborhood is approximately one-half mile away. The area surrounding the Rite-Aid store includes predominately commercial uses and some industrial uses that are located to the west and south of the project location as shown in Figure 3.

Wide Range or Unique Type of Goods and Services: Rite-Aid provides a wide range of goods and services including groceries, household products, convenience foods and drink, healthcare goods, and pharmaceuticals. It should be noted that Rite-Aid does not sell electronic cigarettes or vaping products and sells cigarettes only to persons over the age of 21. PDS determined that the Type 21 license would benefit the neighborhood because of the provision of a wide variety of goods and services. Though there are outlets serving young people within 1,000 feet of the store, PDS determined that the proposed license is compatible with neighborhood character and would provide services in closer proximity to residents and commercial uses.

#### c. Building or Health Code Violations

The Director of PDS must verify that the establishment for which the ABC license is requested has no building or health code violations of record and the use is allowed by the applicable use regulations of the County's Zoning Ordinance.

<u>Analysis:</u> PDS has verified that the subject property for which the ABC license is requested has no building or health code violations on record. The project site is zoned General Commercial (C36) with a "B" Special Area Designator, which allows the Rite-Aid store upon approval of a Site Plan. The Site Plan was approved by the Planning Commission on August 3, 2018 and the Rite-Aid store opened on January 23, 2020.

#### d. Additional Input/Notification of Other Agencies

County of San Diego Health and Human Services Agency (HHSA): Pursuant to Board Policy I-121, HHSA was provided a copy of the proposed ABC license. Board Policy I-121 requires PDS to send a copy of the application to HHSA as part of the review; however an HHSA recommendation of approval is not required for a Determination. HHSA does not think that the proposed ABC license will serve public convenience or necessity based primarily on the overconcentration of licenses in the census tract as determined by the State ABC, as well as the proximity to the adjacent daycare. HHSA routinely determines that a requested ABC license will not serve public convenience or necessity, relying on the State ABC Department's finding that the area is over-concentrated. HHSA comments are included as Attachment E of this report.

County of San Diego Department of Environmental Health (DEH): Board Policy I-121 requires a copy of the application to be sent to DEH for review and comment. The review by DEH is focused on any active health code violations on the site. At the time of the Planning Commission hearing, there are no health code violations on the site, and DEH indicated that they have no issues or concerns with the issuance of the requested ABC license.

**Valley Center Fire Protection District:** The Valley Center Fire Protection District was notified of the requested ABC license at the time of application to the County. The District reviewed the application and indicated to staff they have no issues or concerns with the issuance of the requested ABC license.

Determination of Public Convenience or Necessity: Based on the above factors, PDS has determined that the ABC license requested by Rite-Aid will serve public convenience or necessity. The Sheriff's Department has found that it will not have a negative influence on crime in the area, and PDS has found that the license is compatible with community character as it will provide services closer to existing neighborhoods and commercial areas within an already established store. PDS also found that there are no active building or health code violations on the site. Input from HHSA has been taken into consideration, it should be noted that an over-concentration of existing ABC licenses in a census-tract as determined by the State ABC Department does not mean that the proposed license will not serve public convenience or necessity, but that the proposed license must be reviewed under the three criteria listed in Board Policy I-121 as detailed above. Because PDS found the requested Type 21 ABC license meets the three required criteria, PDS determined that public convenience or necessity would be served by the issuance of the license.

#### D. COMMUNITY PLANNING GROUP (CPG)

On October 14, 2019, the Valley Center CPG voted to recommend approval of the proposed Type 21 ABC license, with a vote of 7-5-0-3 (7 ayes, 5 noes, 0 abstain, 3 vacant/absent). However, because the vote was not a majority, the motion did not carry. A follow-up motion was made to recommend approval of a Type 20 ABC license (off-sale beer and wine) for the Rite-Aid store. This motion carried with a vote of 9-3-0-3 (9 ayes, 3 noes, 0 abstain, 3 vacant/absent).

#### E. PUBLIC INPUT

The project was not noticed to surrounding property owners because Board Policy I-121 does not require ABC licenses be distributed for public noticing. Staff attended the October 14, 2019 Valley Center CPG meeting, during which comments were received from community members related to the overconcentration of alcohol sales in the area and incompatibility with community character. The CPG also stated a desire to moderate the amount of new ABC licenses granted in their area considering inevitable future commercial development which may also request ABC licenses. No written comments were received by PDS during review of the project. The State ABC Department received 20 written comments on the requested ABC license from community members, which are included as Attachment J.

On December 9, 2019, the Valley Center CPG passed a motion to appeal the Determination with a vote of 12-1-0-2 (12 ayes, 1 noes, 0 abstain, 2 vacant/absent). In their appeal, the Valley Center CPG raised concerns with the County's review process, stating that Board Policy I-121 does not allow staff to properly address issues raised by community members. CPG members also stated that they felt County staff did not consider the groups October 14, 2019 discussion and vote for the Type 21 ABC license. CPG members stated that they felt their time had been wasted when they agreed on a compromise which recommended a Type 20 ABC license rather than the proposed Type 21 ABC license. Staff, who attended the December 9, 2019 CPG meeting, clarified that the Director is required to decide on the proposed Type 21 license because that is the application submitted to PDS. The Director cannot deny a Type 21 and approve a Type 20 in a single action.

#### F. RECOMMENDATIONS

Staff recommends that the Planning Commission take the following actions:

Deny the Valley Center CPG appeal and uphold the Director's Determination of Public Convenience or Necessity for the proposed Type 21 ABC license (Attachment C).

Dear Thrifty/Rite Aid:

This letter is to inform you that, pursuant to Section 23958.4 of the Business and Professions Code, the County of San Diego has determined that public convenience or necessity will be served by the issuance of a Type 21 License for the Rite-Aid #6750 located at 28535 Cole Grade Road, Valley Center in the Valley Center Planning Area, Assessor's Parcel Number 188-250-19.

This determination is based on the following criteria as required in the County of San Diego Board of Supervisors Policy I-121:

1. The Sheriff's Department has determined that approval of the proposed alcoholic beverage license sought by the retail outlet will not negatively influence the rate of criminal activity in the neighborhood.

On September 11, 2019 the San Diego County Sheriff's Department provided a letter indicating that when properly conditioned by the State ABC, there would be no reason to believe that the issuance of this license will have a negative influence on crime in the area. The conditions suggested were regarding the hours of sale of alcoholic products, quantities and sizes of alcoholic products, and prohibiting the sale of single servings of alcoholic beverages.

The Planning Commission has reviewed the proposed Type 21 ABC license and determined that the issuance of said license will not negatively influence the rate of criminal activity in the neighborhood.

2. The County has determined that the proposed alcoholic beverage license is compatible with neighborhood character and would be of benefit to the neighborhood.

Planning & Development Services has determined that the proposed alcoholic beverage license is compatible with the neighborhood character and would be of benefit to the neighborhood due to the following factors:

- There are two (2) other establishments selling alcohol within 1,000 feet of the Rite-Aid These establishments are convenience markets with a Type 20 (off-sale Beer and Wine) and a Type 21 (off-sale Beer, Wine, and Spirits). This is not an excessive number of outlets selling alcohol.
- There are no schools or playgrounds within 1,000 feet of the Rite-Aid. There is one (1) park, Cole Grade Park, within approximately 700 feet of the Rite-Aid.
- There are no residential dwelling units within 1,000 feet of the Rite-Aid.
- The Rite-Aid will not be the only establishment with a Type 21 License in the immediate area but due to the wide variety of products it sells, it offers a public convenience.
- On September 19, 2019 the Valley Center Fire Protection District stated they had no comment on the proposed permit.

The Planning Commission finds that the proposed Type 21 ABC license will be compatible with the neighborhood character. This finding is based on consideration of the proximity and number of retail outlets selling alcohol, proximity of the outlet to residential neighborhoods, proximity of the outlet to facilities serving young people, and whether the retail outlet provides a wide range of desirable goods and services or a unique type of goods and services.

3. The Director of Planning & Development Services has verified that the establishment for which the alcoholic beverage license is requested has no active Building Code or Health Code violations of record, and is permitted by the applicable use regulations of the County Zoning Ordinance.

Planning & Development Services has verified that the subject property has no health or building code violations. The off-sale of Beer, Wine, and Spirits (Type 21 License) is consistent with the Eating and Drinking Establishment Use Type which is permitted in the (C36) General Commercial Use Regulation.

The Planning Commission finds there are no building or health code violations on file, and the use is legal.

#### **NOTICES**

The applicant shall agree to operate their establishment pursuant to any requirements placed on the alcoholic beverage license, which will be implemented by the state Department of Alcoholic Beverage Control.

#### **PERMITS**

Please note that building permits are required to construct, enlarge, alter, repair, move, improve, remove, convert, or demolish a building or structure. Permits are also required for plumbing, electrical, and mechanical work. A permit must be obtained prior to construction and prior to occupancy. Failure to obtain a building permit is a violation of the County of San Diego Ordinances.

The issuance of this determination by the County of San Diego does not authorize the applicant for said permit to violate any Federal, State or County laws, ordinances, regulations or policies

including, but not limited to the Federal Endangered Species Act of 1973 and any amendments thereto (16 U.S.C. Section 1531 et seq.).

The determination by the Planning Commission is final. Future appeals may be directed to the California Department of Alcoholic Beverage Control (ABC).

On September 11, 2019 the San Diego County Sheriff's Department provided a letter indicating that when properly conditioned by the State ABC, there would be no reason to believe that the issuance of this license will have a negative influence on crime in the area. The conditions suggested were regarding the hours of sale of alcoholic products, quantities and sizes of alcoholic products, and prohibiting the sale of single servings of alcoholic beverages.

2. The County has determined that the proposed alcoholic beverage license is compatible with neighborhood character and would be of benefit to the neighborhood.

Planning & Development Services has determined that the proposed alcoholic beverage license is compatible with the neighborhood character and would be of benefit to the neighborhood due to the following factors:

 There are two (2) other establishments selling alcohol within 1,000 feet of the Rite-Aid These establishments are convenience markets with a Type 20 (off-sale Beer and Wine) and a Type 21 (off-sale Beer, Wine, and Spirits). This is not an excessive number of outlets selling alcohol.

- There are no schools or playgrounds within 1,000 feet of the Rite-Aid. There is one (1) park, Cole Grade Park, within approximately 700 feet of the Rite-Aid.
- There are no residential dwelling units within 1,000 feet of the Rite-Aid.
- The Rite-Aid will not be the only establishment with a Type 21 License in the immediate area but due to the wide variety of products it sells, it offers a public convenience.
- On September 19, 2019 the Valley Center Fire Protection District stated they had no comment on the proposed permit.
- 3. The Director of Planning & Development Services has verified that the establishment for which the alcoholic beverage license is requested has no active Building Code or Health Code violations of record, and is permitted by the applicable use regulations of the County Zoning Ordinance.

Planning & Development Services has verified that the subject property has no health or building code violations. The off-sale of Beer, Wine, and Spirits (Type 21 License) is consistent with the Eating and Drinking Establishment Use Type which is permitted in the (C36) General Commercial Use Regulation.

#### **NOTICES**

The applicant shall agree to operate their establishment pursuant to any requirements placed on the alcoholic beverage license, which will be implemented by the state Department of Alcoholic Beverage Control.

#### **PERMITS**

Please note that building permits are required to construct, enlarge, alter, repair, move, improve, remove, convert, or demolish a building or structure. Permits are also required for plumbing, electrical, and mechanical work. A permit must be obtained prior to construction and prior to occupancy. Failure to obtain a building permit is a violation of the County of San Diego Ordinances.

The issuance of this determination by the County of San Diego does not authorize the applicant for said permit to violate any Federal, State or County laws, ordinances, regulations or policies including, but not limited to the Federal Endangered Species Act of 1973 and any amendments thereto (16 U.S.C. Section 1531 et seq.).

#### **APPEAL PROCEDURE**

Within ten calendar days after the date of this Determination of the Director, the determination may be appealed to the Planning Commission in accordance with Section 7200 of the County Zoning Ordinance. An appeal shall be filed with the Secretary of the Planning Commission within TEN CALENDAR DAYS of the date of this notice AND MUST BE ACCOMPANIED BY THE DEPOSIT OR FEE AS PRESCRIBED IN THE DEPARTMENT'S FEE SCHEDULE, FORM PDS-369, pursuant to Section 362 of the San Diego County Administrative Code. If the tenth day falls on a weekend or County holiday, an appeal will be accepted until 4:00 p.m. on the following day the County is open for business. Filing of an appeal will stay the determination of the Director until a hearing on your application is held and action is taken by the Planning Commission. Furthermore, the 90-day period in which the applicant may file a protest of the fees, dedications or exactions begins on the date of approval of this Determination.

This determination was made following a review by Behavioral Health Services:

- This is an application for a new Type 21 Off-Sale General, for a retail pharmacy to include beer, wine and liquor proposed in census tract 191.06.
- Pursuant to State Alcoholic Beverage Control (ABC) regulations, census tract 191.06 is allowed a maximum of five
   (5) Off-Sale alcohol licenses.
- There are currently six (6) existing Off-Sale alcohol licenses in census tract 191.06, exceeding the maximum allowable Type 21 Off-sale General licenses.
- Based on ABC regulations, census tract 191.06 is already over-concentrated.
- If approved, this would increase the over-concentration of Type 21 Off-Sale alcohol licenses in this census tract by two (2) licenses, exceeding the maximum allowable Off-Sale licenses determined appropriate by ABC.
- The High Sierra Academy, a preschool and daycare center located at 29235 Valley Center Road is within approximately 1,000 feet.

Discussion and possible response recommendation. ABC Permit for Rite Aid: PDS2019-ABC-19-002 Thrifty Payless Rite Aid #6750 28535 Cole Grade Rd, APN 188-250-19, request for a Type 21 Off-Sale General permit to sell beer, wine, and distilled spirits for consumption off the premises where sold. No applicant's statement available. (Del Pilar)

- Braheem Marabeh introduced himself and presented a slideshow about Rite Aid Core Values. He explained the
  Alcohol Sales Policy that Rite Aid enforces. The company expressly forbids the sale of alcoholic beverages to
  anyone under the age of 21.
- He shared that a number of other products are also restricted such as tobacco, cough syrup, and certain types of medication.
- Associates must go through training for Alcohol/Tobacco sales training requirements and pass with a score of 100%.
- The Electronic Article Surveillance System monitors the liquor area 24 hours a day. Certain types of liquor are only sold behind the counter. Rite Aid has a special locked cap that they place on most liquor bottles. They project that alcohol will make up 7% of the annual sales.
- B. was asked by Mr. Garritson if this Rite Aid will ever have a clinic in it. He said that most newer stores are built will this footprint possibility.
- Ms. Chavez Harmes asked if Rite Aid will act as a good neighbor. The applicant stated that is his goal.
- Mr. Del Pilar shared that the North Village took a 4-1 vote in favor of the ABC Permit for Rite Aid with the condition that alcohol is sold only between 10 a.m. to 10 p.m.. Mr. Garritson asked about what was the reason one member was against the ABC Rite Aid Permit. Mr. Del Pilar said that it was a personal reason. There was discussion about the alcohol application. #### <u>Purpose</u>

To establish criteria and a procedure for making determinations of public convenience or necessity for alcoholic beverage license applications consistent with the requirements of Section 23958.4 of the State Business and Professions Code.

#### Background

In 1994, the Legislature added Section 23958.4 to the State Business and Professions Code which provides that cities and counties review certain alcoholic beverage license applications in areas having an "undue concentration" of such beverage licenses. Local jurisdictions are to determine whether public convenience or necessity would be served by the issuance of these licenses and inform the State Department of Alcoholic Beverage Control.

#### **Policy**

It is the policy of the Board of Supervisors that the Director of Planning & Development Services or, upon appeal, the Planning Commission, shall determine public convenience or necessity for alcoholic beverage license applications. The following criteria and procedure shall be used in making such determinations:

#### Criteria:

- 1. The Sheriff's Department has determined that approval of the proposed alcoholic beverage license sought by the retail outlet will not negatively influence the rate of criminal activity in the neighborhood. In making this determination, the Sheriff has considered factors such as the incidence of:
  - a. Loitering and vandalism.
  - b. Public drinking and drunkenness.
  - c. Illegal drug usage and sales.
  - d. Theft and violent behavior.
- 2. The County has determined that the proposed alcoholic beverage license is compatible with neighborhood character and would be of benefit to the neighborhood. In making this determination, the Director of Planning & Development Services or the Planning Commission has considered factors such as:
  - a. Proximity and number of other retail outlets selling alcohol.
  - b. Proximity of the retail outlet to schools, playgrounds, and other facilities serving young people.

- c. Proximity of the retail outlet to residential neighborhoods.
- d. Whether the alcoholic beverage license provides: (1) a wide range of desirable goods and services; or (2) a unique type of goods or services.
- 3. The Director of Planning & Development Services has verified that the establishment for which the alcoholic beverage license is requested has no active Building Code or Health Code violations of record, and is permitted by the applicable use regulations of the County Zoning Ordinance.

#### Procedure:

- 1. The applicant shall file with Planning & Development Services: a) the application form from the State Department of Alcoholic Beverage Control; b) the County application form and fee; and c) a statement as to why the license application should qualify for a determination of public convenience or necessity.
- 2. A copy of the application shall be sent to the Sheriff's Department for comment. The Sheriff's response to Planning & Development Services will include their determination as to whether the proposed license will negatively influence the rate of criminal activity in the neighborhood.
- 3. A copy of the application shall also be sent to the applicable planning or sponsor group and to the Department of Environmental Health and the Health and Human Services Agency. The planning or sponsor group shall have 30 days to provide a recommendation with regard to compliance of the application with Policy Criterion #2 concerning neighborhood compatibility.
- 4. Planning & Development Services shall verify that the establishment requesting the license has no active Building or Health Code violations of record and conforms to the applicable Zoning Ordinance use regulations. A site visit may be made.
- 5. The Planning Director shall make a decision as to whether a determination of public convenience or necessity can be made based on the criteria above. This decision shall be made within 35 days of the date of filing of a complete application unless a written request for postponement has been received from the applicant.
- 6. The Director of Planning & Development Services' decision shall be transmitted in writing to the State Department of Alcoholic Beverage Control, the applicant, and the planning or sponsor group.

- 7. The decision of the Director of Planning & Development Services may, within ten days of the date of that decision, be appealed in writing by the applicant or the planning or sponsor group to the Planning Commission. An applicant shall pay the appeal fees specified by the County Administrative Code.
- 8. When the appeal is received by Planning & Development Services, the Secretary of the Planning Commission shall schedule the matter for next available Planning Commission meeting. The Director shall provide the Planning Commission with a written brief on the matter and the written appeal.
- 9. The Planning Commission shall consider the matter and render a decision regarding the determination of public convenience or necessity. The decision of the Planning Commission shall be final.
- 10. The decision of the Planning Commission shall be transmitted in writing to the State Department of Alcoholic Beverage Control and to the license applicant.
- 11. Planning & Development Services will take no further action concerning a license application. However, a planning or sponsor group shall not be prevented by this Policy from appealing directly to the State Department of Alcoholic Beverage Control following a Planning Commission decision.

# Attachment I – California Business and Professions Code Section 23958.4

#### State of California

#### **BUSINESS AND PROFESSIONS CODE**

#### **Section 23958.4**

23958.4. (a) For purposes of Section 23958, "undue concentration" means the case in which the applicant premises for an original or premises-to-premises transfer of any retail license are located in an area where any of the following conditions exist:

- (1) The applicant premises are located in a crime reporting district that has a 20 percent greater number of reported crimes, as defined in subdivision (c), than the average number of reported crimes as determined from all crime reporting districts within the jurisdiction of the local law enforcement agency.
- (2) As to on-sale retail license applications, the ratio of on-sale retail licenses to population in the census tract or census division in which the applicant premises are located exceeds the ratio of on-sale retail licenses to population in the county in which the applicant premises are located.
- (3) As to off-sale retail license applications, the ratio of off-sale retail licenses to population in the census tract or census division in which the applicant premises are located exceeds the ratio of off-sale retail licenses to population in the county in which the applicant premises are located.
  - (b) Notwithstanding Section 23958, the department may issue a license as follows:
- (1) With respect to a nonretail license, a retail on-sale bona fide eating place license, a retail license issued for a hotel, motel, or other lodging establishment, as defined in subdivision (b) of Section 25503.16, a retail license issued in conjunction with a beer manufacturer's license, or a winegrower's license, if the applicant shows that public convenience or necessity would be served by the issuance.
- (2) With respect to any other license, if the local governing body of the area in which the applicant premises are located, or its designated subordinate officer or body, determines within 90 days of notification of a completed application that public convenience or necessity would be served by the issuance. The 90-day period shall commence upon receipt by the local governing body of (A) notification by the department of an application for licensure, or (B) a completed application according to local requirements, if any, whichever is later.

If the local governing body, or its designated subordinate officer or body, does not make a determination within the 90-day period, then the department may issue a license if the applicant shows the department that public convenience or necessity would be served by the issuance. In making its determination, the department shall not attribute any weight to the failure of the local governing body, or its designated subordinate officer or body, to make a determination regarding public convenience or necessity within the 90-day period.

(c) For purposes of this section, the following definitions shall apply:

- (1) "Reporting districts" means geographical areas within the boundaries of a single governmental entity (city or the unincorporated area of a county) that are identified by the local law enforcement agency in the compilation and maintenance of statistical information on reported crimes and arrests.
- (2) "Reported crimes" means the most recent yearly compilation by the local law enforcement agency of reported offenses of criminal homicide, forcible rape, robbery, aggravated assault, burglary, larceny, theft, and motor vehicle theft, combined with all arrests for other crimes, both felonies and misdemeanors, except traffic citations.
- (3) "Population within the census tract or census division" means the population as determined by the most recent United States decennial or special census. The population determination shall not operate to prevent an applicant from establishing that an increase of resident population has occurred within the census tract or census division.
- (4) "Population in the county" shall be determined by the annual population estimate for California counties published by the Demographic Research Unit of the Department of Finance.
  - (5) "Retail licenses" shall include the following:
- (A) Off-sale retail licenses: Type 20 (off-sale beer and wine) and Type 21 (off-sale general).
- (B) On-sale retail licenses: All retail on-sale licenses, except Type 43 (on-sale beer and wine for train), Type 44 (on-sale beer and wine for fishing party boat), Type 45 (on-sale beer and wine for boat), Type 46 (on-sale beer and wine for airplane), Type 53 (on-sale general for train and sleeping car), Type 54 (on-sale general for boat), Type 55 (on-sale general for airplane), Type 56 (on-sale general for vessels of more than 1,000 tons burden), and Type 62 (on-sale general bona fide public eating place intermittent dockside license for vessels of more than 15,000 tons displacement).
- (6) A "premises-to-premises transfer" refers to each license being separate and distinct, and transferable upon approval of the department.
- (d) For purposes of this section, the number of retail licenses in the county shall be established by the department on an annual basis.
- (e) The enactment of this section shall not affect any existing rights of any holder of a retail license issued before April 29, 1992, whose premises were destroyed or rendered unusable as a result of the civil disturbances occurring in Los Angeles from April 29 to May 2, 1992, to reopen and operate those licensed premises.
- (f) This section shall not apply if the premises have been licensed and operated with the same type license within 90 days of the application.


