

## **Instructions for Providing Testimony During the April 3, 2020 Planning Commission Hearing through Teleconference**

Due to the Coronavirus disease (COVID-19) public health emergency, the County of San Diego is making several changes related to Planning Commission meetings to protect the public's health and prevent the disease from spreading locally.

California Governor Gavin Newsom issued Executive Order N-29-20 on March 17, 2020, relating to the convening of public meetings in response to the COVID-19 pandemic. Pursuant to the Executive Order, the County of San Diego will allow the public to participate in the meeting via teleconference, in lieu of being physically present.

To provide testimony via teleconference, please follow these instructions:

### **Before Wednesday, April 1, 2020 at 5 p.m.**

1. E-mail your name and the agenda item number you wish to address to [Ann.Jimenez@sdcounty.ca.gov](mailto:Ann.Jimenez@sdcounty.ca.gov) by 5 p.m., on Wednesday, April 1, 2020 so the Planning Commission is aware you wish to speak on that item.

### **On April 3, 2020 at 9 a.m.**

2. You may view the hearing live [online](#) and provide testimony over the phone when the item is heard. Please note that as you view the hearing, not all participants will be in view. The Planning Commission will be convening, but some of the Commissioners will be participating telephonically. *Please note there is around a 45 second delay when viewing the broadcast online.*
