### **Regular Agenda Items**

1. <u>Adopt a Resolution Authorizing Teleconferenced Public Meetings Pursuant to Government Code Section 54953(e)</u> (A. Smith)

This item is for the Planning Commission to consider whether to utilize the Brown Act special teleconferencing rule authorized by AB 361 and if so, adopt the initial resolution. If approved, Planning & Development Services staff will bring back any future findings the Planning Commission may need to make to continue to operate under the special teleconferencing rule.

2. <u>Continued from the December 10, 2021, Planning Commission Hearing Workshop on Vehicle Miles Traveled (VMT) Considering 13 Subjects Related to Implementing VMT During Environmental Review (J. Armstrong)</u>

On May 19, 2021, the Board of Supervisors (Board) received an overview of the County's implementation of SB 743 and its Transportation Study Guide (TSG) for Vehicle Miles Traveled (VMT), including the geographic boundary to calculate average

VMT (unincorporated, regional, and sub-regional), the significance threshold used to evaluate projects (15% below the average VMT), establishing the criteria for which projects must prepare a VMT analysis (110 Average Daily Trips), and whether to establish a Local Mobility Analysis.

The Board directed staff to explore 13 related subjects, including more opportunities for infill development, creation of transit accessible areas, opportunities for affordable housing, and options for VMT mitigation programs.

On September 15, 2021, the Board rescinded the County's TSG based on updated guidance provided by the Office of Planning and Research (OPR) as an update to their website's Frequently Asked Questions (FAQ). One specific item OPR provided clarification on was related to how VMT and geographic boundaries are defined. OPR defined a "region" as the full geography within the jurisdictional borders of a Metropolitan Planning Organization (MPO) or a Regional Transportation Planning Agency (RTPA). For San Diego County, this is the San Diego Association of Governments (SANDAG) region.

Staff will be providing a presentation of the analysis related to the 13 subjects directed by the Board related to the implementation of SB 743 in the unincorporated county. The Planning Commission can receive the presentation, hear comments from the public, and provide comments to the Board on how to implement environmental analysis related to transportation impacts from VMT of proposed projects under CEQA

No appeal is provided for Commission decisions on Administrative Appeals, Variances, or Minor Use Permits; the Commission decision is final. Commission recommendations on General and Specific Plans (and Amendments), Zoning Ordinance Amendments, and Zoning Reclassifications, are automatically presented to the Board of Supervisors, so no appeal is necessary.

\*An "Environmental Determination" is a decision by a non-elected County decision maker, to certify an EIR, approve a Negative Declaration or Mitigated Negative Declaration, or determine that a project is not subject to CEQA.
