### **Summary**

The San Diego Sierra Club requests that the Planning Commission:

- 1) Not adopt the Environmental Findings which include the adoption of a Mitigated Negative Declaration (PDS2023-ER-23-08-008) / SCH# 2025090665 (MND)
- 2) Not Grant Major Use Permit PDS2023-MUP-23-009

Contrary to the January 9, 2026 Planning Commission Hearing Report on the Karve Ski Park Major Use Permit, the plastic material used for the Karve ski surface, poses an unacceptable risk to human health and the environment. This material breaks down into micro and nano plastic particles that contaminate the soil, water, and air. The statement by the General Manager of the Utah Olympic Park that “the plastic turf does not shed material or emit any odor or contaminants” has no scientific basis. The proposed containment strategy will not capture the smaller microplastics or nanoplastics, which is a significant concern as smaller plastics are considered a higher health risk. The manufacturer claims this plastic material is fully recyclable, but it cannot be processed by standard municipal recycling facilities.

The San Diego Sierra Club respectfully disagrees with the finding of **No Impact** for IV. b) Biological Resources and the **Less Than Significant Impact** for X. a) Hydrology and Water Quality. The micro/nano plastics particles that are not captured by the hydrodynamic separator and biofiltration basin will degrade water quality and adversely affect riparian habitat. **At the very minimum, a plan must be put in place to monitor the levels of micro/nano plastic particles produced and the effectiveness of removal techniques.**

### **Hearing Report Response to Letter F**

In response to Mary Clarke's Letter F, the January 9, 2026 Planning Commission Hearing Report on the Karve Ski Park Major Use Permit discusses:

- 1) Composition of the materials used to make JF Dry Ski Surface Mats
- 2) Comments provided by the General Manager of Utah Olympic Park
- 3) Compliance strategy

#### Composition of JF Dry Ski Surface Mat (page 2-534)

*“F-1: The commentor expresses concern about the material used for the artificial ski slope. The applicant plans to install “JF Dry Ski Surface Mats” which have been used at the Utah Olympic Park in Park City, Utah since 2017. The mats are composed of plastic parts and an aluminum alloy base which are considered renewable resources according to the manufacturer (<https://dryskimat.com/sustainability>). Additionally, based on material test sample results available on the manufacturer website, the raw materials used in the manufacturing of the JF Dry Ski mats do not contain any heavy metals or compounds that could be considered toxic air contaminants.”*

#### Comments provided by the general manager of Utah Olympic Park (page 2-534/535)

*“Furthermore, according to the General Manager of the Utah Olympic Park, the plastic turf does not shed material or emit any odor or contaminants (see attached letter dated October 21, 2025). The General Manager also notes that since the mats were first installed in 2017, only a handful of tiles in high-traffic areas have required replacement. It’s anticipated that the ski mats for the proposed project would last approximately ten years without requiring full-scale replacement and replacement would be by individual tile(s) as needed in the more heavily used portion of the ski slope.”*

#### Compliance Strategy (page 2-535)

*“The project’s SWQMP identifies the pollutants of concern for the project and provides a compliance strategy that the project would incorporate into the design. The post development design for Drainage Management Area 2 (DMA-2) would include all flows that pass over the JF Dry Ski material which includes a treatment train to mitigate the pollutants of concern from DMA-2. There are three Best Management Practices (BMPs) in this treatment train and include:*

- Upstream sump area (BMP-B3) which acts as a detention element controlling flow rates leaving the ski slope,*
- Hydrodynamic separator (BMP-B2) which is a Cascade Separator system which is rated to remove 80% of total suspended solids (TSS)*
- Biofiltration basin (BMP-B1) This filtration basin contains 4,064 sq ft of effective filtration area. Storm water will filter through 18" of media, and 12" of gravel before it exits the site.”*

#### **Comments**

The JF dry ski mat website (<https://dryskimat.com/sustainability>) states that polyacetal is the material that comes in contact with the skis. Polyacetal, also known as polyoxymethylene (POM), is a strong, stiff engineering thermoplastic with the basic structure  $(-\text{CH}_2\text{O}-)_n$ . Like other plastics, POM breaks down into micro/nano plastics (MNP's) through weathering (sunlight, oxygen, heat, water) and mechanical abrasion.

The January 9, 2026 Planning Commission Hearing Report on the Karve Ski Park Major Use Permit does not adequately address:

- 1) Degradation of POM plastic bristles to form MNP's
- 2) Toxicity of POM-derived MNP's
- 3) Inability to recycle POM in municipal waste streams
- 4) Inadequacy of the treatment train to capture POM-derived MNP's

### Degradation of POM plastic bristles to form MNP's

I have a PhD in Chemistry and 35 years of industrial experience, with expertise in analytical methods and optical and electron microscopy. The statement by the General Manager of the Utah Olympic Park that “the plastic turf does not shed material or emit any odor or contaminants” has no scientific basis. These are a layperson’s observations, and a detailed analysis is required to show the level of MNP formation.

POM forms MNP’s through physical fragmentation and chemical degradation, primarily driven by UV light and heat via cracking and oxidation, as well as mechanical abrasion. This leads to tiny particles that enter the food chain.

To properly analyze formation of MNP’s, the JF dry ski mat plastic bristles would need to be weighed with high precision before and after exposure to the elements and use as a ski surface. The amount of mass lost would allow you to calculate the number of MNP’s formed. For example, the loss of 1 gram of material per square foot of the Karve ski surface would be imperceptible to the naked eye.

However, this 1 gram of plastic would form 1.35 trillion small microplastic particles that are 1 micron in diameter or 1.37 quadrillion nanoplastic particles that are 0.1 micron in diameter - that’s 1,370,000,000,000,000 particles (if you counted to this number by one number every second, it would take 332 million years!).

### Toxicity of POM-derived MNP’s

The material test sample results available on the manufacturer’s website do not address the harm to human health and the environment caused by POM-derived MNP’s. MNP’s contaminate the soil, water, and air and harm wildlife by being ingested, causing physical blockages, toxicity from adsorbed pollutants (heavy metals, PCBs), disrupting food webs, altering soil health, affecting marine microbes, and even carrying pathogens or invasive species, disrupting nutrient cycles and threatening biodiversity from plankton to humans. MNP’s are pervasive, entering food chains from the bottom up, impacting everything from soil fauna like earthworms to top predators and humans. The inclusion of significant amounts of artificial turf in the Karve plans only adds to the level of MNP’s and toxic materials that will be released into the environment.

The adverse health effects of micro-and-nano plastics are well documented in the scientific literature. Here are two examples:

*The potential impacts of micro-and-nano plastics on various organ systems in humans*

([https://www.thelancet.com/journals/ebiom/article/PIIS2352-3964\(23\)00467-X/fulltext](https://www.thelancet.com/journals/ebiom/article/PIIS2352-3964(23)00467-X/fulltext)) - “The summarized results suggest that exposure to MNP’s can lead to health effects through oxidative stress, inflammation, immune dysfunction, altered biochemical and energy metabolism, impaired cell proliferation, disrupted microbial metabolic pathways, abnormal organ development, and carcinogenicity.”

*Microplastics are everywhere and can harm human health, say experts*

(<https://hsphs.harvard.edu/news/microplastics-are-everywhere-and-can-harm-human-health-say-experts/>) - “Microplastics - tiny fragments formed when plastic products degrade - have been detected in human tissues at increasing rates in recent years and have been linked with a variety of health harms. Experts from Harvard T.H. Chan School of Public Health say that more should be done to limit plastic pollution around the world.”

### Inability to recycle POM in municipal waste streams

According to the manufacturer, polyoxymethylene is fully recyclable; however, as an engineering thermoplastic, it cannot be processed by standard municipal recycling facilities. The most commonly recycled plastics are #1 PET (Polyethylene Terephthalate) for bottles and #2 HDPE (High-Density Polyethylene) for jugs, as they have strong, established recycling markets and are widely accepted in curbside programs, often recycled into new bottles, fibers, or lumber. #5 PP (Polypropylene) can also be recycled in municipal facilities, while #4 LDPE (Low-Density Polyethylene) (films/bags) can be recycled but often needs special drop-offs. #7 plastics, such as POM, are generally much harder to recycle and standard municipal recycling facilities do not accept these materials. The letter from the General Manager of the Utah Olympic Park confirms that while the aluminum base from the JF dry ski mat can be reused or recycled, the plastic bristles are not recycled.

### Inadequacy of the treatment train to capture POM-derived MNP's

Hydrodynamic separator (HDS) systems have limited effectiveness at capturing the very small end of the microplastic spectrum, but are efficient at removing larger, settleable particles (typically  $>100 \mu\text{m}$ ). Their performance is heavily dependent on the microplastic's size, shape, and density. The primary limitation of HDS systems is that the centrifugal forces may be insufficient to effectively separate the smallest microplastics and nanoplastics from the surrounding water.

Filtration basins are highly effective at capturing larger microplastics (e.g.,  $>20 \mu\text{m}$ ), but are less effective for smaller particles. The smaller microplastics and nanoplastics will pass through the Drainage Management Area 2 system, contaminating soil and the surrounding watershed, which is a significant concern as smaller plastics are considered a higher health risk.

### **Mitigated Negative Declaration**

The San Diego Sierra Club respectfully disagrees with the following findings in the Mitigated Negative Declaration:

IV. BIOLOGICAL RESOURCES -- Would the project:

b) Have a substantial adverse effect on any riparian habitat or other sensitive natural community identified in local or regional plans, policies, regulations or by the California Department of Fish and Wildlife or US Fish and Wildlife Service?

**- No Impact**

X. HYDROLOGY AND WATER QUALITY -- Would the project:

a) Violate any water quality standards or waste discharge requirements or otherwise substantially degrade surface or groundwater quality?

**- Less Than Significant Impact:** Projects have the potential to generate pollutants during both construction and operation.

The plastic material used for the Karve ski surface will degrade, producing micro and nano plastic particles that contaminate the soil, water, and air. The proposed containment strategy will not capture the smaller microplastics or nanoplastics which have the most adverse effects on human health and the environment. The micro/nano plastics particles that are not captured by the hydrodynamic separator and biofiltration basin will degrade water quality and adversely affect riparian habitat. **At the very minimum, a plan must be put in place to monitor the levels of micro/nano plastic particles produced and the effectiveness of removal techniques.**

As a resident of the surrounding community, I—along with many of my neighbors—have significant concerns regarding the project's potential impacts and the limited information provided by both the developer and San Diego County. Based on the details available, this project is likely to negatively affect our quality of life by increasing noise levels, creating traffic hazards, and straining local infrastructure.

It is important to note that the listed project address is not the proposed entrance. Instead, the developer intends to use Tierra Libertia Road—a narrow, single-lane private road—as the primary entrance and exit for the amusement park. The developer has also acknowledged that the site lacks sufficient parking for the proposed use. With no public transportation options available, the proposed reservation system for up to 100 guests per hour will, in practice, result in traffic congestion during peak times, particularly when residents are attempting to return home. A more effective mitigation would be to require the developer to construct a dedicated entrance and exit on N. Centre City Parkway, along with a left-turn lane serving both the ski park and Tierra Libertia Road.
