- 1. Wind Energy Ordinance Amendment Workshop; POD 10-007; Countywide (Schneider) Continued from the April 27, 2012**

This is an informational workshop intended to provide the Planning Commission additional data regarding the siting of wind turbines within the unincorporated San Diego County. The County is proposing amendments to the Zoning Ordinance and General Plan. The amendments consist of clarifications, deletions, and revisions to provide an updated set of definitions, procedures, and standards for review and permitting of wind turbines.. The workshop will provide a forum for staff to provide additional information and for further public input regarding a variety of issues related to the siting of small and large wind turbines. Workshop data will be used for Planning Commission deliberations when providing a recommendation to the Board of Supervisors on the Wind Energy Ordinance Amendment as part of a future Planning Commission hearing.
