2. This report includes general property characteristics to aid in preparing plans and documentation for the submittal of building permit application. This information includes general parcel characteristics, zoning information, seismic design info, unresolved parcel flags, districts, flood, fire hazard severity, agencies, climate zones and more. ### **Accessory Dwelling Unit (ADU) Fee Waiver Program:**

In an effort to help with housing affordability, the Board of Supervisors approved a 5-year-trial fee waiver program (January 2019 – January 9, 2024) for Accessory Dwelling Units (ADUs), or "Granny Flats", in the unincorporated communities of the County of San Diego. To qualify for fee waivers, the ADU needs to be located on a site with an existing single-family dwelling The program waives building permit fees and onsite wastewater system permit fees, as well as traffic, park, and drainage impasses in the unincorporated County.
