

To Whom It May Concern:

Please be advised that a Phase I cultural resource survey has been conducted on the above referenced project by Brian F. Smith & Associates, Inc. (BFSA). Results of the survey data have determined that no cultural resources are present on the property. The project consists of the development of a nine-acre parcel (Figures 1 through 3). The project is identified as Assessor's Parcel Number (APN) 678-060-27. The project area is located directly southeast of the intersection of Four Gee Road and Campania Avenue adjacent to 4S Ranch, San Diego County, California. Specifically, the property is located at Township 13 South, Range 2 West in Section 19 of the USGS Escondido 7.5' topographic quadrangle, as plotted on Figure 3.

Description: This archaeological study conformed to County of San Diego guidelines. Statutory requirements of CEQA were followed in evaluating potential impacts. The survey of the property utilized intensive archaeological reconnaissance that consisted of a pedestrian survey of the nine-acre parcel. Transects, spaced approximately one-to-three meters apart were employed in a north-to-south orientation across the project area. The majority of the parcel was flat and covered with agricultural fields. Much of the property was covered in vegetation that obscured the ground surface. Areas lacking vegetation cover principally along the eastern portion of the property were intensely surveyed to determine the presence of surface deposits and potential for subsurface materials. Limitations of the archaeological survey included vegetation from agricultural use. No artifacts or features were identified during the survey. The project proposes the development of the nine-acre parcel for church facilities (see Figure 2).

Record Search: A records search was conducted for the property by BFSA on November 15, 2010 at the South Coastal Information Center. A total of 33 studies have been completed within a one mile radius of the project area. In addition, a total of 99 sites have been identified within a mile radius of the property. However, no sites have been previously identified within the project area. The closest site to the property (SDI-12,747) is approximately 220 feet southeast of the project area. The majority of the sites within the record search radius are prehistoric Native American sites.

Native American Consultation: A sacred lands file search was submitted to the Native American Heritage Commission on November 9, 2010. To date, no response has been received. Sacred Lands File information for the project will be updated when the results are known. Per County of San Diego requirements, a Native American monitor, Larry Sutton from Red Tail Monitoring (Kumeyaay), was present for the duration of the field survey.









Figure 2


