Is there not a problem with water? I let my lily pond die years ago to save water. Will swimming pools be allowed? I have no lawn-watering twice a week for 10 minutes was not enough. It didn't come back even with the rain. WE HAVE A WATER SHORTAGE AND HAVE HAD MY 68 years in San Diego!!!

What are the evacuation plans? It has only gotten worse in the past 10 years. I do not want to burn to death!!

Why should people who have been in the area 50-60 years have to be disturbed for out of county profiteers who really don't care about our current and future problems? Just say NO! The Golden Door is a great asset to our area and they and current residence of the whole area should have first consideration.
