Description:

The project consists of grading for the pad for a single family home and appurtenant culvert to be sited generally within the eastern portion of the surveyed area (the southeastern quadrant of the APN).

The whole access road which splits the parcel (APN 223-081-50-00) in an east-west direction was surveyed, as well as the area extending 5 m north of/along the road, and the whole portion of the parcel south of the road (see Figure 1). Part of the area to the north of the road was signed as part of the "Rancho La Costa Habitat Conservation Area." The project lies on a moderately steep west-facing slope. The parcel is on a north-south trending slope which eventually becomes an erosional canyon and its western corner is located 275 m south-east of an intermittent stream known as Copper Creek. Construction of high-voltage transmission towers and access roads, as well as a reservoir, a water tank, and SDG&E electric facilities at the top of the 860-foot high point just to the north-east of the project site, has resulted in minimal impact to the survey area. With the exception of the graded access road and small mountain-bike paths running in many directions over the survey area (just visible in Figure 1 and see Photograph 2), the property appears to have remained in its natural state.

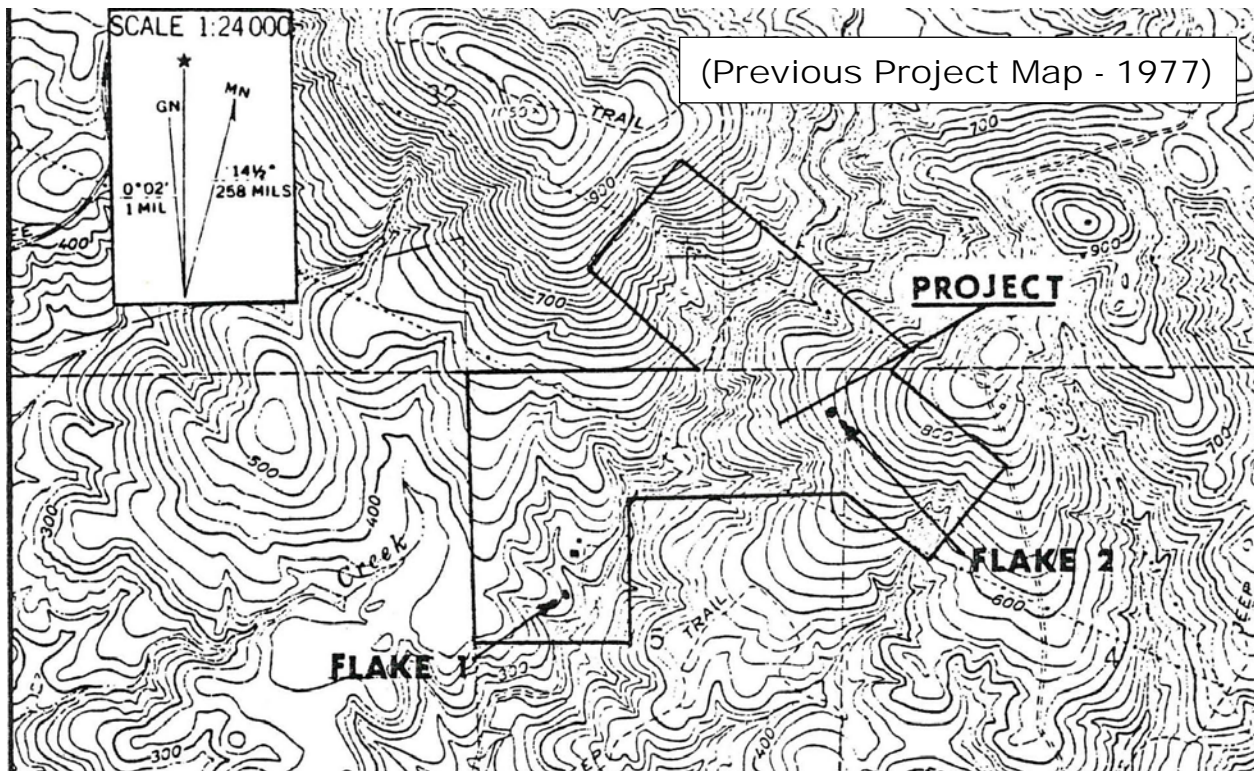


Figure 2. From "Archaeological Reconnaissance of the Copper Hills Subdivision" by John R. Cook, 1977.

While the field survey was conducted using standard archaeological procedures and techniques, continuous parallel transects were not possible due to the high dense brush (disturbed coastal sage scrub with underlying tall non-native grasses) in some areas. The survey used the extensive system of bike paths to get around the dense brush, and areas in between the bike paths were walked in 10 m transects where possible. Granitic outcrops suitable for milling were lacking in the survey area, and no other evidence of cultural use of the area was identified in this survey. No prehistoric or historic artifacts or features were identified in the survey, and the flake found in the 1977 archaeological survey by James Cook and crew just west of the property line was also not relocated. Unfortunately, this flake was never officially recorded as an isolate on the proper DPR forms, though its location is mapped in the Archaeological Survey Report "Archaeological Reconnaissance of the Copper Hills Subdivision" by James Cook (see Figure 2).

Prior Research: Staff conducted a records search of the surrounding area using the California Historic Resources Inventory System (CHRIS). Sixty three studies have been conducted within a one mile radius, four of them within the project APN. Eleven cultural sites were identified with a one-mile radius, none within the project APN. No historic properties were identified within a one mile radius or inside the APN.

Of the four studies conducted within various portions of the APN (Table 1), a survey covering the project area and adjacent 250 acres conducted in 1977 by John R, Cook et al., was most extensive. This survey report identified two flakes (see Figure 2). One of these two flakes was located just outside the current survey area to the southwest. The flake identified by Cook and his team was not relocated. Cook's conclusions, documented in the 1977 report, hold true to this day. He states that "the project property has a somewhat low potential for having been utilized prehistorically as evidenced by the dearth of archaeological resources." He adds that "although the area was undoubtedly marginally exploited as a secondary hunting and gathering zone, the type and degree of on-site resources evidently militated against habitational or even less intensive, shorter duration special extraction sites" (Cook, 16).

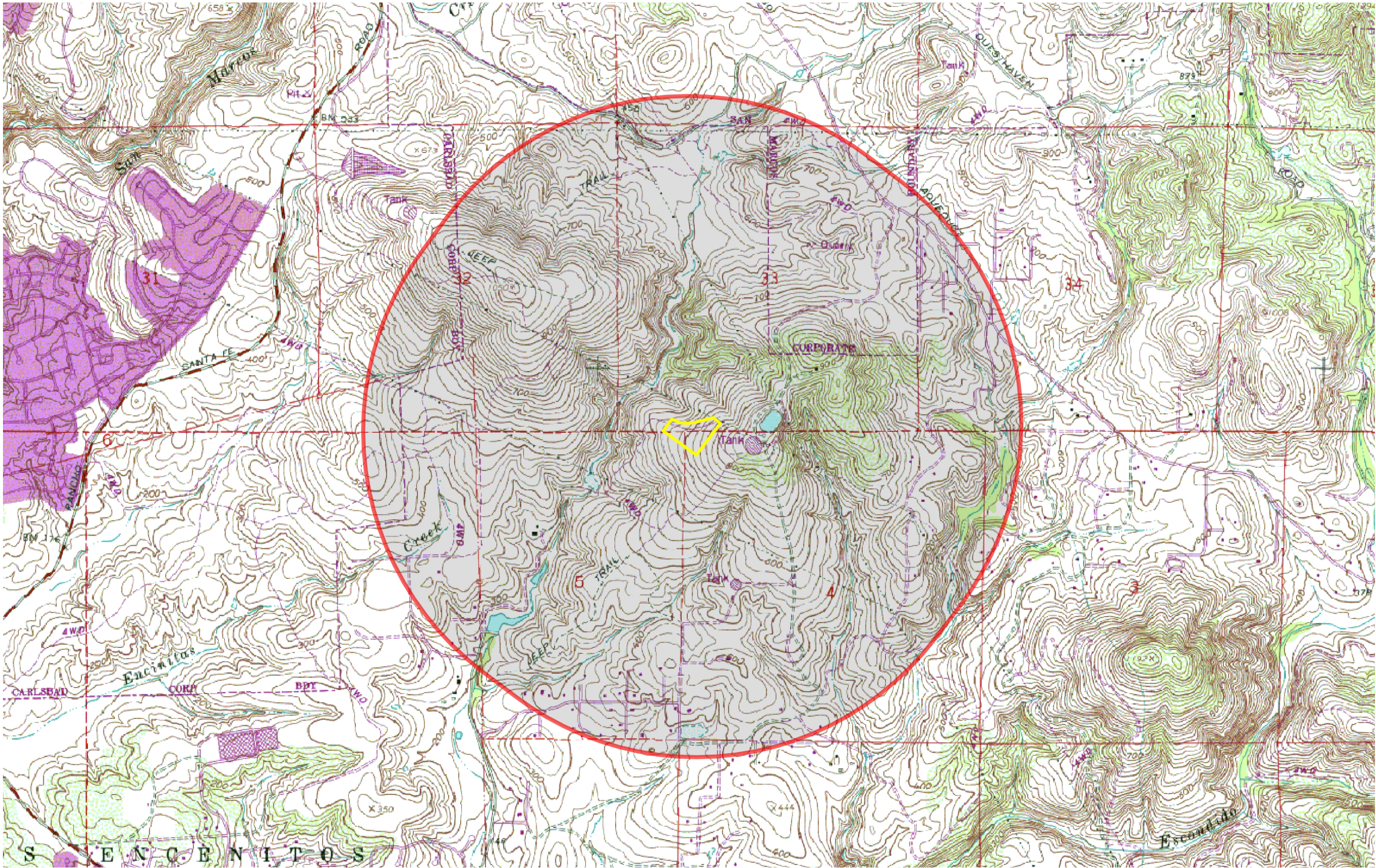
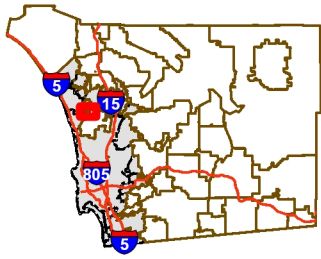
