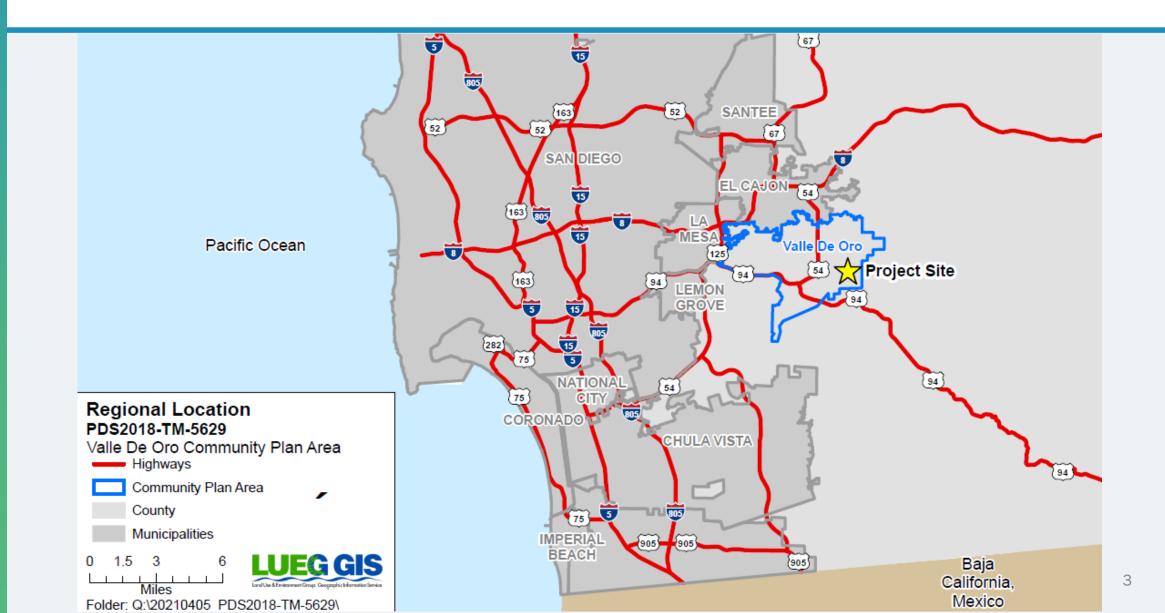

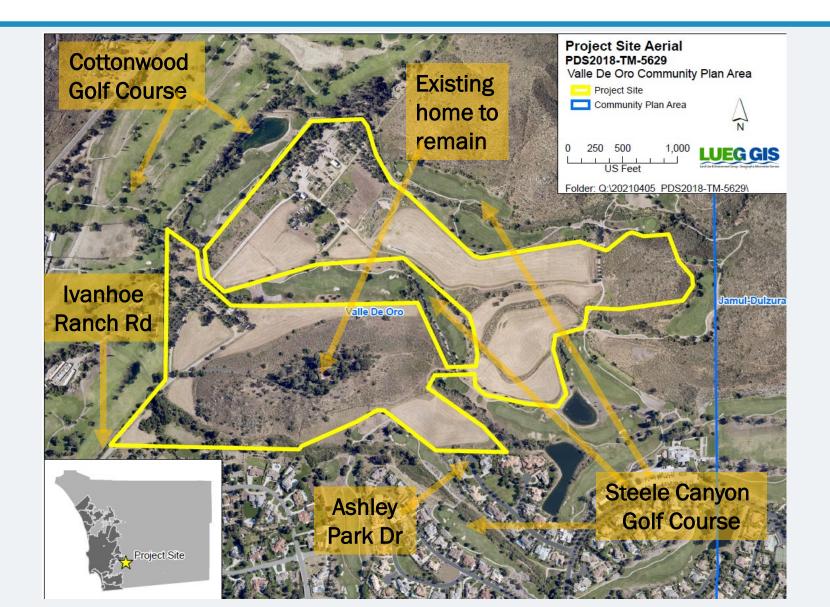

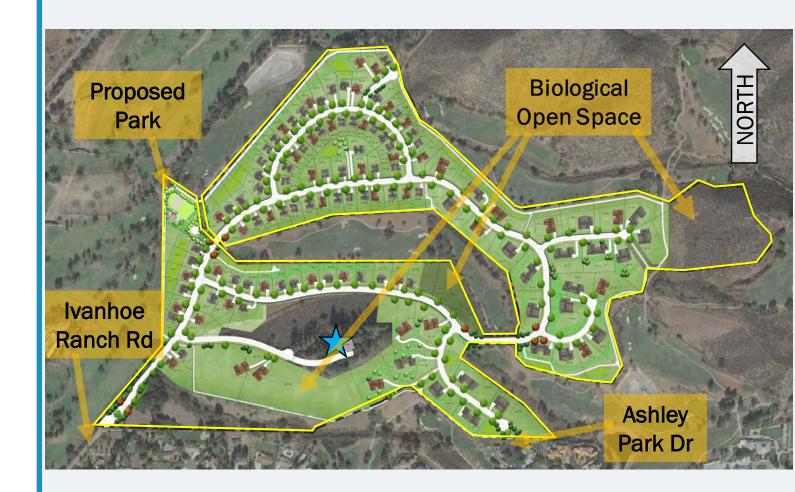

General Plan Amendment - Land Use Designation

Existing*

Semi-Rural (SR-10) allows 1 dwelling per 10 or 20 acres = 11 dwellings Open Space Recreation

Proposed*

Semi-Rural (SR-2) allows 1 dwelling per 2, 4, of 8 acres Semi-Rural (SR-0.5) allows 1 dwelling per $\frac{1}{2}$, 1, or 2 acres = 120 dwellings

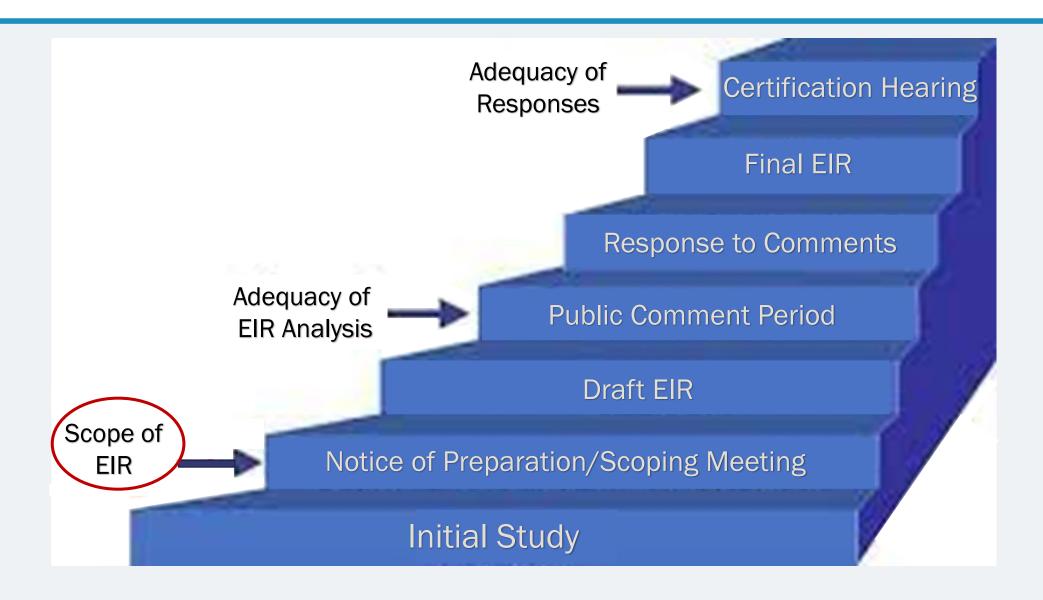

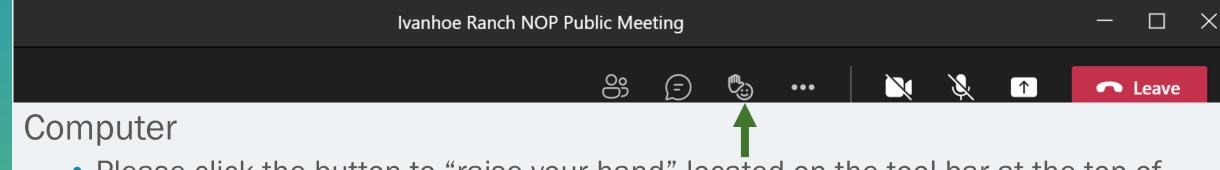
