### **QUESTION**

What is the expected timeline for the final EIR and consideration by the Planning Commission and the Board of Supervisors?

#### **REPSONSE**

The Draft Environmental Impact Report (EIR) was advertised for public review from October 8, 2020 to December 7, 2020 and responses to the comments received from the public are currently being drafted. The Project is anticipated to be heard by the Planning Commission in Summer 2021 and by the Board of Supervisors in Fall 2021.

### **QUESTION**

In a previous iteration, the project was planning to seek a General Plan Amendment and Zone Reclassification in addition to a Major Use Permit. Now it appears to be only seeking a Major Use Permit. What changed? Who initiated the change?

## **REPSONSE**

The EIR notice of preparation for the Project included a General Plan Amendment (GPA) and a Rezone, however after further review of the proposal when submitted, we determined that the project would not trigger the need for a GPA or Rezone. The applications for the GPA and Rezone were subsequently withdrawn by the Project applicant. No changes to the exiting General Plan Land Use Designations or Zoning are proposed by the applicant.
