Hi Susan and Nicholas, my name is Jeff Osborne, I am the owner of Jacumba Hot Springs Resort and a new member of the Jacumba Sponsor Group

As discussed on the call on October 28th, I am concerned about the time frame to respond to this Draft EIR.

Even during normal times, a 45 comment period on a DEIR this lengthy seems a bit short, but right now, we are under the pressures of a pandemic, in a remote, elderly community, with limited internet access. The only real place many members of our community can access the EIR is at the community library and the library has been closed for long periods or has been on limited hours due to COVID. The library is also a place some higher risk members of our community have been reducing their visitations to, to reduce their exposure risk.

On top of all of this, we are going into Thanksgiving week.

In light of these unique and specific circumstances, I wanted to formally request a 2 week extension on the Draft EIR comment period.
