I'm not sure exactly which standard you are referring to? Please see attached for the Standard Drawings for driveways. Since many of these designs are for sidewalks, you would probably have to modify one of the designs since sidewalk is not required for the project. A maximum width of 30' is allowed for commercial driveways. The driveway standard would apply at the ultimate pavement location, with tapers to the existing pavement. These items would have to be discussed with the Traffic Engineer, if you want to deviate from any standards. Thanks,



Hope you're doing well and staying safe.

I had a quick question I was hoping you'd be able to help answer for me. The driveway entrance off of Carrizo Gorge Road that is being used to access the SDGE switchyard is a 30' wide road and has a proposed driveway radius of 50'. The County standards shows 24' wide and 30' radius for the typical driveway entrances. I just want to confirm that it is acceptable to exceed those dimensions, correct? Hope to hear back soon.
