I don't really have much info to provide on this one because when the project was last submitted for Final Engineering review, an effective review could not be performed (I had only looked at the grading plans, not the drainage study). At that time, there weren't any conditions for the Discretionary action because of concurrent processing. Also, discussions regarding the deviation from the County's acceptable hydrologic methods for the project were still going on between PDS LD and DPW. As such, the discretionary team took the lead on the project. The applicant's engineering team had stated in a meeting that they were not going to be resubmitting for Final Engineering until a Discretionary Permit had been obtained. I do not know where the project stands today. I recommend the team reach out to the discretionary group for insight.
