Dear Supervisors Anderson, Vargas, Lawson-Remer, Fletcher, Desmond, and their land-use advisors:

**This letter is to request that the supervisors delay their vote on Agenda Item 1 (JVR solar project) on Aug. 18, 2021, to give residents more time to evaluate the feasibility of setting up an EIFD (Enhanced Infrastructure Financing District) in Jacumba Hot Springs - District 2.**

An EIFD will allow for the collection of TIF (Tax Increment Financing) funds for the redevelopment of Jacumba in order to build a thriving economy and an enhanced tax base.

Since your vote on this land-use issue will determine if JVR Energy Park is given control of the only land available for growth, it is of great concern to the citizens of Jacumba. It seems only fair that we be given some time to explore another viable option. As it is, the solar park will provide no collective benefits to our residents. However, an EIFD will provide an alternative use of the proposed land with a variety of benefits to the community. These include the development of:

- affordable housing, bypassing the VMT (Vehicular Miles Traveled) restriction;
- community space, like a town hall/auditorium, museum for this historic and storied region, and art gallery as a venue for the many resident artists;
- business space for services like a laundromat, hardware store, and office rental;
- infrastructure for our airport to encourage more frequent use by gliders and private pilots;
- low-impact landscaping (and maintenance) for existing community organizations, such as the community park and seniors center, as well as our downtown area.

These kinds of projects will not only boost our economy by providing short- and long-term jobs but also increase our ability to attract tourists. With the new ownership and development of the Jacumba Hot Springs Spa and Jacumba Lake, these kinds of improvements are critical to the success of rebuilding a once

flourishing tourist destination. One has only to look at other communities like Temecula to see the possibilities an EIFD can offer.

We're asking for a chance to expand and prosper, to recreate a community that we (and you) can be proud of, that will sustain us and provide our next generations with a positive future. If the JVR Park project is allowed to build on the only land available for such growth, it not only ties up this land for thirty-five years, but also sets a precedent for blocking it off in perpetuity.

The possibility of a very different future for Jacumba is in your hands.

We're asking you, at the very least, to **delay your vote**.

A resident of San Diego county for 45+ years in District 4 and a new landowner in District 2 (Boulevard), I am in strong opposition to the current 600+ acre mega solar project that will surely **devastate a historic, low-income San Diego community** and permanently damage wildlife and ecosystems in the area.

This project will completely engulf this at-risk community and destroy its only economic engine - *tourism*. The proposed project is 6 times the size of the quaint town of Jacumba and is planned to sit within a stone's throw from homes and businesses. - The Ramona Community Planning Group asks that your board provide for strong mitigation to provide a method of conflict resolution and method of enforcement for the future.

The Equity for Jacumba solar project alternative would, over time, allow for a measured expansion of residential, agricultural, and recreational land uses. Dear Supervisors,

After reviewing the main elements of the proposed 600-acre Jacumba Valley Ranch (JVR) Solar project (Major Use Permit; PDS2018-MUP-18-022) at our planning group meeting held on August 9, 2021, we urge Supervisors vote to deny the JVR project which is on your August 18, 2021 meeting agenda. The placement of this enormous facility within the Jacumba rural village boundary will devastate the quality of life for the poor residents who reside in Jacumba Hot Springs and the future sustainability of this small town.

Instead, Supervisors should request that BayWa, the JVR project developer, works earnestly on a compromise with the community which would include a smaller project footprint and other elements addressed in the community's Equity for Jacumba alternative. This alternative is Jacumba's proposal to retain some of its valued community character, create lasting economic opportunities for their residents, and restore important wildlife habitat, while accommodating the future development of an up to 300-acre JVR solar facility, the largest permitted facility in the County. Specifically, the "Equity alternative" as envisioned by the Jacumba Community Sponsor Group would:

- Eliminate the dangerous placement of solar facility components around three sides of the Jacumba airport runway, which is used by single engine and glider aircraft.
- Reserve land for the eco-friendly future expansion of the village of Jacumba, and its local airport within the rural village boundary next to residences and along scenic Highway 80.
- Preserve selected historic resources from the former Mountain Meadow Dairy which has been part of Jacumba's visual landscape since the late 1920s as an educational experience for visitors. (This dairy was one of the largest early dairies in San Diego County.)
- Promote eco-tourism by creating trail head access to the southern part of Anza Borrego Desert State Park (ABDSP) next to Jacumba and a network of community trails and pathways that promote physical well-being of Jacumba residents and visitors.

- Build a viable connection between the Carrizo Gorge in ABDSP and the international border to maintain landscape connectivity functions within this region of San Diego County and cross-border habitat in Baja California.

Jacumba Hot springs is one of the County's poorest communities. A smaller and more reasonably placed solar facility as envisioned in the Equity for Jacumba solar project alternative would over time, allow for a measured expansion of residential, agricultural, and recreational land uses. This expansion would provide a reliable revenue stream to the local economy, while preserving Jacumba's community character and critical wildlife habitat. It would also accommodate the development of an appropriately-sized solar energy facility that will not destroy the future of the town.

Thank you for recognizing the social and environmental injustice impacts that a 600-acre industrial solar facility would have on Jacumba's residents and voting to deny the current JVR project.

### **ENVIRONMENTAL HEALTH AND QUALITY ADVISORY BOARD LETTER OF SUPPORT**

On April 28, 2021, the Environmental Health and Quality Advisory Board (EHQAB) voted unanimously to support the Department of Environmental Health and Quality (DEHQ) entering into a new revenue agreement with the California Department of Public Health (CDPH) for a 3-year term spanning Fiscal Years 2021-22, 2022-23, and 2023-24.


