Below are the high-level issues. Attached are the details for the historic comments that were received.

Historic Resources (Buildings)

- Commenters question the determination that the dairy is not a significant resource. The believe it to be a significant resource.
 - Dairy and Ranch complex were evaluated for significance under all criterion of CEQA and found not to be a significant resource – lacks significant historic associations and has compromised integrity.
 - Resources evaluated under National Register of Historical Places (NRHP), California Register of Historic Resources (CRHR), and Local Register of Historic Resources (Local Register).

Archaeological

Archaeologica

- 28 impacted sites/portion of sites (8)determined not significant.
- 39 sites/portion of sites (8) outside ADI avoided and preserved.
- Mitigation Temp Fencing, Monitoring, Treatment Agreement & Preservation Plan, Long-Term Preservation Plan (Decommissioning)

Tribal Cultural Resources

- Sacred lands file check (conducted by consultant)/AB-52 Consultation no TCRs/Sacred Lands identified but area identified as sensitive.
 - Carmen Lucas (Kwaaymii) stated she did not have knowledge of any specific TCRs that may be impacted by the Proposed Project but that Jacumba is a sacred area and that "not one inch" of the area does not have cultural significance. She recommended that a qualified Native American monitor be present during survey of the Proposed Project. She also recommended that forensic dogs be used to identify human remains. She did not respond to County outreach for AB-52 consultation.
 - County consulted with Barona, Campo, Jamul, Manzanita, Viejas.
 - Consultation was concluded with Barona, Campo, Jamul, and Viejas. No TCRs were identified.
 - Manzanita consultation concluded due to lack of response on 5/27/2020. Outreach sent on 1/7/02020, 2/25/2020, 4/7/2020, and 5/27/2020.
 - Outreach to Manzanita as a stakeholder County still willing to meet to discuss concerns 2/25/2021, 8/12/2021. No response received.
- Manzanita comment letter (public review) primarily focused on government-to government

consultation and claims that the County did not consult in good faith. Letter identified two sacred mountains which were already identified by the project consultant.
