IRRIGATION STATEMENT

- I) THE IRRIGATION SYSTEM SHALL COMPLY WITH THE REQUIREMENTS OF THE COUNTY OF SAN DIEGO WATER EFFICIENT LANDSCAPE ORDINANCE AND CALIFORNIA EXECUTIVE ORDER B-29-15.
- 2) ALL PLANTED AREAS SHALL HAVE AUTOMATIC IRRIGATION SYSTEMS. SHRUB AND GROUND COVER AREAS SHALL UTILIZE LOW-VOLUME SUBSURFACE DRIP EMISSION DEVICES, PREVENTING RUNOFF AND OVERSPRAY. TURF AREAS SHALL UTILIZE LOW PRECIPITATION RATE ROTATOR NOZZLES
- 3) THE AUTOMATIC CONTROLLER SHALL BE A SMART CONTROLLER, WITH WEATHER SENSING FEATURES AND FLOW MANAGEMENT CAPABILITIES.
- 4) THE IRRIGATION SYSTEM VALVES SHALL BE SEPARATED BY HYDROZONE, WITH RESPECT TO SIMILAR SITE, SUN EXPOSURE, SOIL CONDITIONS AND PLANT MATERIAL WITH SIMILAR WATER USE
- 5) TREES SHALL BE PLACED ON SEPARATE VALVES FROM SHRUBS AND GROUND COVER, UTILIZING DEEP ROOT BUBBLERS.
- 6) THE PROJECTS ESTIMATED WATER USE (ETWU) SHALL NOT EXCEED THE MAXIMUM APPLIED WATER ALLOWANCE (MAWA).

WATER CONSERVATION CONCEPT STATEMENT:

THIS LANDSCAPE CONCEPT PLAN COMPLIES WITH THE REQUIREMENTS FOR LANDSCAPE IMPROVEMENT PLANS AS DESCRIBED IN THE SAN DIEGO COUNTY CODE TITLES, DIVISION 6, CHAPTER 7 AND HAS BEEN PREPARED IN COMPLIANCE WITH THOSE REGULATIONS. THE USE OF DROUGHT TOLERANT PLANT MATERIAL ENSURES A WATER WISE SITE PLAN FOR THE COUNTY OF SAN DIEGO. RECYCLED WATER WILL NOT BE USED AT THIS SITE. AN ON-STE WATER WELL IS PROPOSED FOR IRRIGATION WATER USE.

INVASIVE SPECIES NOTE:

NO INVASIVE PLANT SPECIES SHALL BE USED, PER THE CALIFORNIA EXOTIC PEST PLANT COUNCIL LIST A-I, AND CALIFORNIA INVASIVE PLANT COUNCIL, (CAL-IPC).

MAINTENANCE NOTE:

ALL LANDSCAPE ARES WILL BE MAINTAINED BY THE OWNER.

PLANTING NOTES

- NO PLANTING OTHER THAN GROUNDCOVER IS TO BE WITHIN 3' OF THE FACE OF CURB ADJACENT TO PARKING STALL
- 2) ALL PLANTING WITHIN CORNER SIGHT LINE DISTANCE AREAS SHALL HAVE A MAXIMUM MATURE HEIGHT OF 30".
- SCREENING ALONG YORK DRIVE IS TO BE SCREENED BY SOLID VINYL FENCING. ALL PLANTED AREAS SHALL RECEIVE A 3" LAYER OF SHREDDED BARK MULCH.
- PLANTS SHALL BE SELECTED FOR DROUGHT TOLERANCE AND LOW MAINTENANCE, EXCEPT FOR LIMITED AREAS SUCH AS RESIDENT GARDENS, TURF AREAS, ACCENT AREAS OR BMP AREAS.






