Regular Agenda Items**1. Soitec Solar Development (Tierra Del Sol Solar and Rugged Solar); PDS2012-3300-12-007; PDS2012-3600-12-005; PDS2012-3921-77-046-01; PDS2012-3300-12-010, & PDS2012-3910-120005 (Gungle)**

The Soitec Solar Development Program Environmental Impact Report includes the analysis of two projects (Rugged Solar and Tierra Del Sol Solar) at a project level and the analysis of two projects (LanWest and LanEast) at a program level.

The applicant proposes a Rezone, Agricultural Preserve Disestablishment and a Major Use Permit for the Tierra Del Sol Solar project and a Major Use Permit for the Rugged Solar project for the construction and operation of two solar facilities.

The 765-acre Rugged Solar project site is located north of Interstate 8, east of Ribbonwood Road and primarily west of McCain Valley Road and the 420-acre Tierra Del Sol Solar project site is located south of Interstate 8, south of Tierra Del Sol Road and adjacent to the United States-Mexico border.

The Rugged Solar and Tierra Del Sol Solar projects would utilize similar solar generation technologies, would include similar common project components, and would have similar construction, operation, and decommissioning activities. The solar generation technology for these projects includes concentrated photovoltaic (CPV) which utilize a dual-axis tracking system and are also referred to as “trackers”. The entire tracker assembly measures approximately 48 feet across by 25 feet tall and is mounted on a 28-inch diameter steel mast pole. Other components of the projects include inverter stations, underground collection systems, overhead trunk lines, operations and maintenance buildings, and onsite substations.

The Rugged Solar project would deliver power to the SDG&E’s Rebuilt Boulevard Substation via the 138 kV Tule gen-tie on a 69 kV undersling line. The Tierra Del Sol Solar project would deliver power to the Rebuilt Boulevard Substation via an approximately 6-mile dual circuit 138 kV gen-tie line with sections of the line occurring both overhead and underground.

The Rugged Solar site is subject to the General Plan Rural Regional Category, Rural Lands 80 (RL-80) Land Use Designation and is zoned General Rural (S92) and A72 (General Agricultural). The Tierra Del Sol Solar site is subject to the General Plan Rural Regional Category, Rural Lands 80 (RL-80) Land Use Designation and is zoned General Rural (S92) and A70 (Limited Agricultural).

No appeal is provided for Commission decisions on Administrative Appeals, Variances, or Minor Use Permits; the Commission decision is final. Commission recommendations on General and Specific Plans (and Amendments), Zoning Ordinance Amendments, and Zoning Reclassifications, are automatically presented to the Board of Supervisors, so no appeal is necessary.

The address for filing with the Planning Commission is: San Diego County Planning Commission, 5510 Overland Avenue, Ste 110, San Diego, CA 92123. Appeals must be accompanied by the appeal fee of \$1000.00.

*An "Environmental Determination" is a decision by a non-elected County decision maker, to certify an EIR, approve a Negative Declaration or Mitigated Negative Declaration, or determine that a project is not subject to CEQA.
