Hi Ashley,

The draft final PEIR includes a new element that was not analyzed in the draft PEIR, namely the addition of battery energy storage. What are the dates for the public comment period on that new element? I'm still going through the documentation, but so far I've not seen an official Notice or anything else explaining that public comment period. Is there perhaps a link that I haven't yet found?

Protect Our Communities would like to comment formally on that new element and have our comments included in the final PEIR. For example, we have detailed information regarding an avian mass death event at a renewable energy project's battery energy storage facility that we would like to submit into public comments, as well as recommendations for how to avoid a similar event at the Soitec projects. This would include modifying at least one of the project's proposed mitigation measures.
