

- Modification to the project that may lessen the project's environmental effects


PROJECT LOCATION



PROJECT LOCATION (SITE AERIAL)



PROJECT DESCRIPTION

- 100 Megawatt Solar Facility with 217.4 Megawatt Battery Storage
- Two Phase Construction
 - 1st Phase 20 Megawatts of Solar and 17 Megawatts of Battery Storage
 - 2nd Phase 80 Megawatts of Solar and 200 Megawatts of Battery Storage
- Collector Substation
- Underground Generation Tie-Line
- 12-18 Months of Construction
- Private internal roads
- Approximately 350,000 cubic yards of balanced cut/fill

 - Construct a 100 Megawatt Solar and 217.4
 Megawatt Battery Storage Facility


