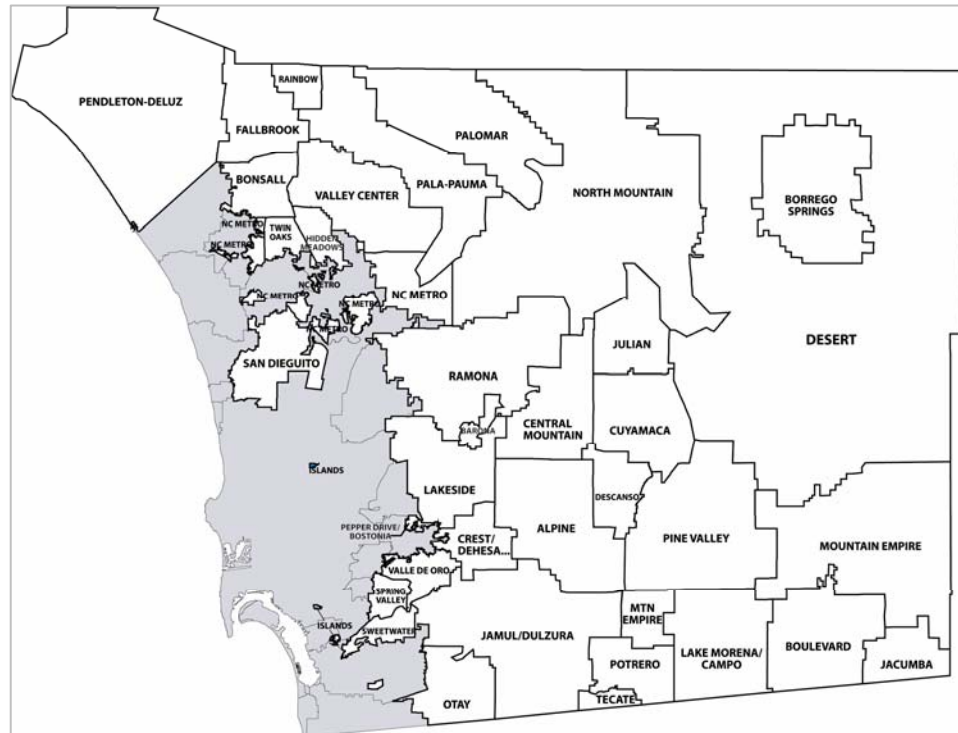

## OVERVIEW

The Board of Supervisors endorsed the draft goal/policy statements prepared by the Steering Committee on January 10, 2001 for use as a guide during the mapping process. Those draft goal/policy statements were subsequently reviewed and amended by the Interest Group Committee, which completed its review in July 2002.

### **GP2020 Policy Documents**

All goal and policy statements prepared by the GP2020 Advisory Groups will be reviewed and amended, as appropriate, for inclusion in the Draft General Plan 2020

Regional Elements. The Draft Regional Elements will be subject to public review and to review by the Planning Commission and Board of Supervisors.

Goal and policy statements will be contained in one or more of the following elements:

1. Land Use Element
2. Circulation Element
3. Conservation and Open Space Element
4. Public Facilities Element
5. Housing Element
6. Noise Element
7. Safety Element

In addition to goal and policy statements, the GP2020 documents will contain technical and legal information related to each policy statement.
