1. Windsong Storage Container: Windsong Lane Escondido, CA 92026 (APN187-020-66-00 1339)

Applicant is applying for a B designator exemption for a proposed 3,000 sq. ft. storage container. Applicant is applying for a B designator exemption for a proposed 2,000 sq. ft detached steel construction garage. The as-built storage facility project lacks power, water, and HVAC systems. Building cannot be seen from the highway and meets all engineered plans. Foundation plans and special inspections were confirmed to be completed and submitted. However, the need for fire sprinklers and fire marshal approval is required before granting final approval. The group voted to give a conditional approval pending fire marshal sign-off. They also noted that there were no further projects on Daisy Lane and confirmed the next meeting date for January 14th.

2. SDGE Limiting Pressure Station PDS2025-ZAP-90-002W1 3210 Rainbow Valley Blvd Fallbrook, CA 92028 (APN 102-650-04-00). SDGE is installing a pressure limiting station on SDGE owned land. Station will regulate gas pressure into San Diego County. Submission is for a building permit for 2 structures to be installed: 12x14ft cement masonry block wall with barbed wire fencing and fiberglass shelter to house instrumentation & electrical equipment and fiberglass shelter to house security & electrical equipment. The new pressure limiting station project for SDG&E will be 4 feet from Rainbow Valley Boulevard, though there was some confusion about the exact distance and its impact on neighboring property visibility. The project team confirmed they have been in communication with the affected landowner for over a year and addressed concerns about graffiti maintenance, which would be handled by SDG&E's operations and maintenance team.
