2. APPROVAL OF MINUTES (Action): September 25, 2025

Motion to approve as presented by Rob Lewallen and seconded by Bruce Nolan. Motion passed 4-0-1-0 with Anderson abstaining.

5. WAIVER REQUESTS (Action)

a. 2260 Main Street (The Lipo Lounge, Signage) - LeiLani Vidal

Items Presented:

- Signage plan to replace existing monument sign with updated sign
- Backlit letters connected to existing electrical.
- Proposed letter height does not exceed 9"
- Discussion on if the sign was a monument or a pole sign ensued between members and Dyer. Dyer argued that the existing signage was the tenant's only available signage and that it could be approved as legal non-conforming. Lewallen and Anderson referenced that it could only be approved if the sign was built prior to 1978. Dyer questioned if the board knew for certain that the sign was built after this date and Anderson said that it was. Further discussion ensued on what the tenant could do to get the signage approved. Tenant explained that they already invested in the sign. Lewallen and Anderson suggested rebuilding the sign to meet existing form based code standards.

- 5. Tenant agreed to later build a block base at the bottom of the monument sign as requested by Lewallen and Anderson.
