## ITEM 3 - TAYLOR RESIDENCE; PDS2021-MAA-21-002

**Property Owner:** Carolina and Paul DiGregorio **Location:** 4925 Resmar Road, La Mesa, CA 91941 (APN#496-34-15-00); Supervisor District 2

### **Description:**

The Taylor Residence is a single-family residence constructed in 1956 by William Cody and Henry Hester in the California Ranch Architectural Style. The applicant is requesting designation under criteria V(b)(3) of the Local Register.

**Today's Action:** Consider the application for the Taylor Residence for designation to the County's Local Register and participation in the Mill's Act Program and make a recommendation to the Director of Planning & Development Services.

**Staff Recommendation:** Staff recommends participation in the Mills Act Program and placement of the Taylor Residence on the Local Register of Historic Resources as Landmark Number 2021-002. The period of significance for this resource is proposed as 1956 through 1959 as that is the original construction period associated with the residence and pool. Staff finds this resource to be significant under the County's Local Register of Historical Resources Ordinance 9493 under criterion V(b)(3).
