When will the East County MSCP be worked on?	Once the North County Plan is completed, staff will seek Board direction for the eastern portion of the county
What accounts for the long length of time between the South County Plan adoption and the North County Plan?	Many reasons, including the General Plan Update becoming a priority and additional time to gain appropriate staff and financial resources.
How was the PAMA determined?	The PAMA was determined through remoting sensing data and modeling that was calibrated with available survey data.
Are habitat impact mitigation fees being included? From the development perspective, increased mitigation ratios are not favorable. However, impact fees are considered a better way forward, and would be supported over increased mitigation ratios.	Not currently being planned for, but could be proposed.
Does the PAMA align with species occurrences?	Yes, the PAMA was partially determined by the species prediction model.
What is the percent of existing species necessary to maintain viable population?	Still under development; however, the amount necessary to maintain a viable population is more likely to be expressed as "occurrences" rather than a percentage of species' population
How does the County of San Diego know what is on private property?	Two types of data are included in MSCP modeling efforts: 1.) Observations from public and private lands seeking discretionary project approvals; and 2.) Remote sensing data. Results are a combination of conceptual models and survey results
