(Eira Whitty, PDS) 	<ul style="list-style-type: none"> Chula Vista has a one-time Preserve Management Endowment Fund of \$2 million specifically for Quino (Cheryl Goddard, City of Chula Vista)
<ul style="list-style-type: none"> What monitoring requirements does the Chula Vista MSCP have for Quino? (Eira Whitty, PDS) 	<ul style="list-style-type: none"> Monitoring includes an initial baseline survey and surveys every three years after Surveys are only conducted in years with suitable conditions and do not include larval surveys (Cheryl Goddard, City of Chula Vista)
<ul style="list-style-type: none"> Quino monitoring years 	<ul style="list-style-type: none"> 2017 Quino monitoring was a banner year <ul style="list-style-type: none"> Specifically, the McMillan Property and adjacent State lands had abundant adult Quino observed during the 2017 flight season USFWS collected Quino adults from the City's property in 2017 <ul style="list-style-type: none"> These adults have been used to stock/raise Quino larvae at the existing Quino lab at the San Diego Zoo (captive breeding program for reintroduction at USFWS Refuge lands)
<ul style="list-style-type: none"> What conservation strategy did the Chula Vista MSCP Subarea Plan implement for Quino? (Peter Eichar, PDS) 	<ul style="list-style-type: none"> The conservation strategy focuses on conservation of existing known Quino locations and management and monitoring for Quino The Chula Vista MSCP Subarea Plan details a Wildlife Agency/City of Chula Vista Quino team that would direct \$50,000 per year to Quino management and monitoring (Cheryl Goddard, City of Chula Vista)
<ul style="list-style-type: none"> Are adaptive management measures included in the Chula Vista Subarea Plan? (Eira Whitty, PDS) 	<ul style="list-style-type: none"> No, the Chula Vista MSCP Subarea Plan does not include adaptive management thresholds or measures (Cheryl Goddard, City of Chula Vista)

<ul style="list-style-type: none"> Preserve/Owner Manager (POM) lands are managed by Chula Vista. If additional lands were to be conveyed to the POM, it would require additional funds 	<ul style="list-style-type: none"> County and City of Chula Vista staff will work together to understand existing funds and monitoring in the POM and Otay Ranch Phase 2 Resource Management (RMP2) lands (All)
