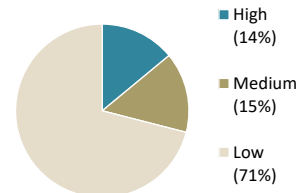
Gender



Ethnicity



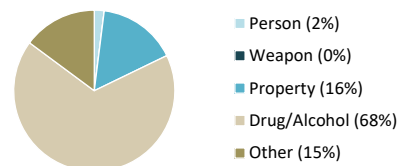
