- D. BIDDERS as specified in the Bidding Instructions shall be required to submit a Prequalification and be prequalified by PCL seven (7) days prior to the Bid Date.
- E. Each BIDDER, simultaneously with the execution of the Subcontract Agreement, shall be required to furnish a Labor and Material Payment and Performance Bond in an amount equal to 100% of the Contract Sum. Said Bonds shall be from an admitted California Surety satisfactory to PCL Construction Services, with an A.M. Best rating of A- or better, and listed in the Federal Register, issued by the Department of Treasury and licensed in California. Or Subcontractor shall be preapproved to join PC's Contractor Default Insurance Program (Subguard). Said Bonds shall remain in full force and effect through the guarantee period.
- F. The BIDDER shall be a licensed contractor pursuant to the Business and Professions Code and be licensed in the applicable classifications for the trades for which the contractor is submitting a bid.
- G. No Bid may be withdrawn until sixty (60) days after the Bid Opening Date.
- H. PCL reserves the right to reject any and all bids or to waive any irregularities or informalities in any bid or in the bidding.
- I. PCL is an 'equal opportunity' employer and encourages LSDBE (MBE, WBE, DBE, DVBE, SBE and OBE) Participation.
