Ms. Markow expressed thanks for the inquiry; said she was not sure if Politifest would include any redistricting discussion in 2021, given that it did have such a session in 2020; and nonetheless noted with appreciation that the VoSD editorial team would be discussing Politifest later this week, where she would note the inquiry.
