

D. Experience Qualifications

State law requires candidates demonstrate experience in areas related to redistricting. Please provide responses to the following questions.

1. What experience do you possess that demonstrates analytical skills relevant to the redistricting process and voting rights, and demonstrates your ability to comprehend and apply the applicable state and federal legal requirements?

I ran a nonprofit 501(c)3 organization which led the 2-year effort to stop licensure of fitness professionals in the state of California. We did this through the development of a nationwide certification examination that would establish the first professional standards for fitness instructors. Prior to that, no standards existed and the industry was unregulated. Faced with the option of state licensing vs. self-regulation, the industry preferred self-regulation.

Anyone who has developed a standardized, legally-defensible certification examination understands the complexity of the process. I brought stakeholders together — academia, fitness centers, equipment manufacturers, training organizations, fitness professionals and celebrities, etc. — to provide input on the process and content of the national standard. It was at a time the industry was divided and polarized by competitive groups. Each group was rightfully concerned about the impact of any change to their business. Because both businesses and individuals stood to benefit from the output of the work, the task required diplomacy and a fair process for gathering input.

A psychometric testing service was brought in to help define the process and further ensure our product would be a valid, reliable and legally defensible certification examination. Psychometricians guided the process ensuring the diversity/composition of industry experts chosen to attend our exam writing meetings. The work product of the group was further sent out for validation in controlled surveys that ensured diversity and representation by all parties.

After launching the certification, there was continuous statistical monitoring of the exams, and psychometric and legal protocols were observed regarding exam administration and exam maintenance. Our thorough, transparent and fair exam development process produced a certification that was well received by the industry and became a standard in 70 countries. We never had a legal challenge to the work in the 15 years I ran the company.

Over the years, multiple quality exams have emerged and today the fitness industry is still self-regulated.

2. What experience do you possess that demonstrates an ability to be impartial?

For me, being impartial means having the ability to separate myself from my beliefs, opinions and personal interests so that I can fully listen to and evaluate another perspective.

In my work developing a legally-defensible, certification examination I demonstrated my commitment to being impartial by bringing together diverse groups of professionals and stakeholders and establishing a process for equal representation. Because of their diversity, they often came to the table with strong opinions and it was not uncommon for the group to get into heated debates. Facilitated by trained psychometricians, the best part was that we learned to listen and more often than not, we all broadened our perspective and were more unified than before we began. In fact, the strong bond and friendships that developed remain some of the best in my life.

In my management of a nonprofit business I organized annual strategic planning meetings. Even though I played a leadership role, I saw it as critically important for me to step aside and provide avenues for my board, staff and committees to have input. I utilized an outside consulting group, to help design and facilitate processes that included collection of internal and external factors and data that were affecting our business and meetings to allow input and debate from my board, staff and committees. While you cannot please everyone, it is possible to provide an opportunity for people to express themselves and look for ways their thoughts and ideas can be incorporated into a bigger picture. Being inclusive, listening to people and letting them be heard builds a stronger team, develops a better product/service, and just as important - a unified voice at the end. The result was a strategic planning document that guided our budget development and business operations for the next year.

Another demonstration of my commitment to being impartial is my participation recently at a workshop by the nonprofit group, Braver Angels. Braver Angels was established to help bridge the divide in America by bringing opposing groups together to help people better understand the experiences and beliefs of those on the other side of the political divide and to help people find commonality and develop friendships.

For Californians to have faith in the work done by the Redistricting Commission, it is important for all those who participate to feel they have been heard. That won't happen if Commissioners can't put personal opinions aside and actively listening to the thoughts and perspective of the public and their fellow Commissioners.



3. What experience do you possess that demonstrates an appreciation for the diverse demographics and geography of the County of San Diego?

I was raised from the time I was a toddler in San Diego and have resided and worked in what is currently the 5th Supervisorial District for the past 30+ years. I am very familiar with its geographical and demographical diversity and I've spent a lifetime demonstrating my belief in the value of diversification through decisions I have made about job choices, how I pursue business, what educational focus my children have, etc. I firmly believe we are stronger together.

Here are examples:

- * After college, in response to legislation that ended forced busing, I chose to be one of the first teachers to teach new curriculum as part of San Diego's first magnet program encouraging voluntary integration at Lincoln High. (This was despite the fact I was physically attacked and knocked out when I had attended a high school basketball game at that same school 6 years earlier for no reason other than being at the wrong place at the wrong time.)
- * I've made choices to pursue speaking Spanish because of the community I grew up in here in San Diego with our borders neighboring Mexico. In the 80's I ran a student store in Vermont for the School for International Training. It was there that I became somewhat fluent in Spanish (after years of Spanish in high school) since most of my customers were from Latin America and spoke little English. As a mother of two children, I enrolled my kids in the bilingual education track available to them to encourage a second language and to develop cross-cultural appreciation and friendships.
- * I was one of the few women in a leadership role nationally in the fitness industry when I ran my company in the 80's and 90's. I experienced my share of challenges being a woman, so in my running of the nonprofit I ran for 15 years it was vitally important to me to employ people based on merit. I was proud to be a woman-run business that employed men and women, gay and straight, black and white, young and old, etc.
- * In my 13 years of work in residential real estate in north county I became intimately aware of the diverse range of demographic, sociological and geographic conditions that people care about in selecting a home and community to live in and raise children. I worked with first-time home buyers, seniors downsizing, growing families, and handled tragic situations in the late 2000's handling short sales and foreclosures. I learned what people care about in selecting a place to live whether that be city growth plans, water issues, traffic, building ordinances, zoning, the quality of schools, coastal regulations, and the list goes on. Working intimately with families and helping them with one of the biggest financial investments they will likely make in their lives, gave me an understanding of the unique communities that make up San Diego, especially in North County where I focused. And helping people find that perfect place that met their needs was the most fulfilling part of the job.
